

A BILL FOR AN ACT

To appropriate the sum of \$215,093 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for the purpose of reappropriating certain funds which lapsed September 30, 1994, under Public Law No. 7-96, as amended, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$138,967, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the Federated
3 States of Micronesia for the fiscal year ending September 30, 1995, for the
4 purpose of funding elementary and secondary education needs in the State
5 of Chuuk. The sum appropriated under this section shall be apportioned as
6 follows:

7	(1) Faichuk.....	\$ 758
8	(2) Southern Namoneas.....	47,779
9	(3) Northern Namoneas.....	3,779
10	(4) Mortlocks.....	28,714
11	(5) Western, Namonuito and Hall Islands.....	39,494
12	(6) Chuuk High School.....	18,443

13 Section 2. The sum of \$3.00, or so much thereof as may be
14 necessary, is hereby appropriated from the General Fund of the Federated
15 States of Micronesia for the fiscal year ending September 30, 1995, for the
16 purpose of funding elementary and secondary education needs in the State
17 of Pohnpei. The sum appropriated under this section shall be apportioned
18 as follows:

19	(1) Election District 1.....	\$ 1
20	(2) Election District 2.....	1
21	(3) Election District 3.....	1

22 Section 3. The sum of \$76,122, or so much thereof as may be
23 necessary, is hereby appropriated from the General Fund of the Federated
24 States of Micronesia for the fiscal year ending September 30, 1995, for the
25 purpose of funding elementary and secondary education needs in the State

1 of Yap. The sum appropriated under this section shall be apportioned as
2 follows:

3	(1) St. Mary's School.....	\$ 50,000
4	(2) Yap Continuing Education.....	22,835
5	(3) Yap Department of Education.....	3,287

6 Section 4. The sum of \$1.00, or so much thereof as may be
7 necessary, is hereby appropriated from the General Fund of the Federated
8 States of Micronesia for the fiscal year ending September 30, 1995, for the
9 purpose of funding elementary and secondary education needs in the State
10 of Kosrae.

11 Section 5. All funds appropriated by this act shall be allotted,
12 managed, administered, and accounted for in accordance with applicable
13 law, including, but not limited to, the Financial Management Act of 1979.
14 The allottee of the funds appropriated under subsection (2) of section 1 of
15 this act shall be the Southern Namoneas Development Authority. The
16 allottee of the funds appropriated under subsection (4) of section 1 of this
17 act shall be the Lower Mortlocks Development Authority. The allottee of the
18 funds appropriated under subsections (1), (3), (5) and (6) of section 1,
19 and sections 2, 3 and 4 of this act shall be the President of the Federated
20 States of Micronesia or the President's designee. The allottees shall be
21 responsible for ensuring that these funds, or so much thereof as may be
22 necessary, are used solely for the purposes specified in this act, and that no
23 obligations are incurred in excess of the sum appropriated. The authority
24 of the allottees to obligate funds appropriated by this act shall not lapse.


