A BILL FOR AN ACT

To appropriate the sum of \$215,093 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for the purpose of reappropriating certain funds which lapsed September 30, 1994, under Public Law No. 7-96, as amended, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

3	States of Micronesia for the fiscal year ending September 30, 1995, for the

The sum of \$1.00, or so much thereof as may be 7 necessary, is hereby appropriated from the General Fund of the Federated 8 States of Micronesia for the fiscal year ending September 30, 1995, for the purpose of funding elementary and secondary education needs in the State 9 10 of Kosrae. Section 5. All funds appropriated by this act shall be allotted, 11 managed, administered, and accounted for in accordance with applicable 12 13 law, including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated under subsection (2) of section 1 of 14 this act shall be the Southern Namoneas Development Authority. The 15 allottee of the funds appropriated under subsection (4) of section 1 of this 16 act shall be the Lower Mortlocks Development Authority. The allottee of the 17 funds appropriated under subsections (1), (3), (5) and (6) of section 1, 18 and sections 2, 3 and 4 of this act shall be the President of the Federated 19 States of Micronesia or the President's designee. The allottees shall be 20 responsible for ensuring that these funds, or so much thereof as may be 21 necessary, are used solely for the purposes specified in this act, and that no 22 obligations are incurred in excess of the sum appropriated. The authority 23 of the allottees to obligate funds appropriated by this act shall not lapse. 24 25
