To further amend title 2 of the Code of the Federated States of Micronesia, as amended, by amending section 103 for the purpose of establishing a line of succession of officers of the Federated States of Micronesia to act as President in the absence of other qualified individuals, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 103 of title 2 of the Code of the
2	Federated States of Micronesia is hereby amended to read as
3	follows:
4	"Section 103. Vacancy in the Offices of President and
5	<u>Vice President</u> .
6	(1) If both the President and Vice President die,
7	resign, or are impeached, or are not able to perform the
8	functions and responsibilities of the Office of the
9	President due to unexpected absence or leave, the Speak
0	of the Congress at-large member of the Congress of the
1	Federated States of Micronesia representing the same
2	State of the President's electorate shall immediately
3	assume the powers and duties of the President as Acting
14	President/ qqd the; PROVIDED, however, that the member
15	upon becoming Acting President shall not lose any or all
16	of his rights as a member of the Congress. The Congress
7	shall within thirty days of the last vacancy elect a
8	President and Vice President, convening for that purpose
9	if not in session, and declare vacancies in the Congress.
20	If the Office of the Speaker is vacant, or it the Speaker
21	dies by resigns from Congress burning said thirty-day
22	pleniou, the Nible Speaken shall inhimediately assume the
23	powers and dutiles of the President as Acting President.
24	If the at-large member designated as the Acting
25	President is unable to serve, dies, resigns or is

1	impeached during his tenure, the next succeeding official
2	to be designated as Acting President shall follow the
3	most senior, with respect to age, of the at-large
4	members of the Congress of the Federated States of
5	Micronesia from the other respective States.
6	(2) The President or the Vice President whenever
7	he becomes Acting President, may not further delegate
8	the functions and responsibilities of the Office of the
9	President to any official of the executive departments or
10	offices thereof.
11	(3) The President and the Vice President may not,
12	together or separately, leave the Office of the President
13	or the State in which the capital of the FSM is located,
14	thereby causing both of them together or separately to be
15	absent from the Office of the President and having that
16	State conduct the constitutional and statutory
17	responsibilities of the Office of the President."
18	Section 2. This act shall become law upon approval by the
19	President of the Federated States of Micronesia or upon its becoming
20	law without such approval.
