PRESIDENTIAL COMM. NO. FSM CONGRESS

AN ACT

To further amend Public Law No. 7-96, as amended by Public Laws Nos. 7-126, 8-4 and 8-8, by further amending section 1, as amended by Public Law No. 7-126, for the purpose of modifying the use of certain funds previously appropriated therein for Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
