CONGRESSIONAL BILL NO. 8-151, C.D.1

AN ACT

To appropriate the sum of \$48,291.28 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1994, for the payment of money judgments rendered against the Government of the Federated States of Micronesia as provided by section 705 of title 6 of the Code of the Federated States of Micronesia, and for the payment of a settlement amount as agreed to by the National Government of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$22,350.40, or so much thereof as may be
- 2 necessary, is hereby appropriated from the General Fund of the
- 3 Federated States of Micronesia for the fiscal year ending September 30,
- 4 1994, for the payment of a money judgment rendered against the
- 5 Government of the Federated States of Micronesia in the Trial Division
- 6 of the Supreme Court of the Federated States of Micronesia in Civil
- 7 Action No. 1990-088, and plaintiff's attorney's fees.
- 8 Section 2. The sum of \$25,000, or so much thereof as may be
- 9 necessary, is hereby appropriated from the General Fund of the
- 10 Federated States of Micronesia for the fiscal year ending September 30,
- 11 1994, for the payment of a money judgment rendered against the
- 12 Government of the Federated States of Micronesia in the Trial Division
- 13 of the Supreme Court of the Federated States of Micronesia in Civil
- 14 Action No. 1986-3016.
- 15 Section 3. The sum of \$250, or so much thereof as may be
- 16 necessary, is hereby appropriated from the General Fund of the
- 17 Federated States of Micronesia for the fiscal year ending September 30,
- 18 1994, for the purpose of paying the \$250 which the National Government
- 19 agreed to pay to the plaintiff in the case of Linter Tolenoa v.
- 20 Tafunsak Municipality, Kosrae State and the Federated States of
- 21 Micronesia, Kosrae Case No. 36-85, in settlement thereof.
- 22 Section 4. The sum of \$690.88, or so much thereof as may be

- 1 necessary, is hereby appropriated from the General Fund of the Federated
- States of Micronesia for the fiscal year ending September 30, 1994,
- for the payment of a money judgment rendered against the Government
- of the Federated States of Micronesia in the Trial Division of the
- Supreme Court of the Federated States of Micronesia in Civil Action 5
- No. 1992-2001. 6
- Section 5. All funds appropriated by this act shall be allotted, 7
- managed, administered, and accounted for in accordance with applicable
- law, including, but not limited to, the Financial Management Act 9
- of 1979. The allottee shall be responsible for ensuring that these
- funds, or so much thereof as may be necessary, are used solely for the
- purposes specified in this act, and that no obligations are incurred 12
- in excess of the sum appropriated. The authority of the allottee to 13
- obligate funds appropriated by this act shall not lapse. 14
- Section 6. This act shall become law upon approval by the 15
- President of the Federated States of Micronesia or upon its becoming 16
- law without such approval. 17
