I am pleased to transmit the following Congressional Act, which I have signed into Public Law No. 20-115:

Congressional Act No. 20-112, entitled: "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 18-11, AS AMENDED BY PUBLIC LAWS NOS. 18-44, 18-81, 19-33, 19-106, 19-128, 19-134, 19-138, 20-11, 20-49, 20-55 AND 20-62 BY AMENDING SECTION 2 THEREOF, TO CHANGE THE LAPSE DATE OF FUNDS PREVIOUSLY APPROPRIATED THEREIN TO ASSIST THE STATES OF POHNPEI AND YAP IN RETIRING DEBT AND COVERING BUDGET SHORTFALLS, AND FOR OTHER PURPOSES."

This act is extending the lapse date to September 30, 2019, of certain funds to assist Pohnpei and Yap passed by the 18th FSM Congress in 2013. Thank you.

AN ACT

To further amend Public Law No. 18-11, as amended by Public Laws Nos. 18-44, 18-81, 19-33, 19-106, 19-128, 19-134, 19-138, 20-11, 20-49, 20-55 and 20-62 by amending section 2 thereof, to change the lapse date of funds previously appropriated therein to assist the States of Pohnpei and Yap in retiring debt and covering budget shortfalls, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 2 of Public Law No. 18-11, as amended
- 2 by Public Laws Nos. 18-44, 19-128, 19-138 and 20-11, is hereby
- 3 further amended to read as follows:

4	"Section 2. Allotment and management of funds and
5	lapse date. All funds appropriated by this act shall be
6	allotted, managed, administered and accounted for in
7	accordance with applicable laws, including, but not
8	limited to, the Financial Management Act of 1979. The
9	allottee shall be responsible for ensuring that these
10	funds, or so much thereof as may be necessary, are used
11	solely for the purpose specified in this act, and that
12	no obligations are incurred in excess of the sum
13	appropriated. The allottee of the funds appropriated
14	under subsection 1 of section 1 of this act shall be the
15	President of the Federated States of Micronesia or his
16	designee; PROVIDED THAT, the allottee of funds
17	appropriated under subsections l(b)(vi) 1(d)(i) and

1	Section 2. This act shall become law upon approval by the
2	President of the Federated States of Micronesia or upon its
3	becoming law without such approval.
