I am pleased to transmit the following Congressional Act, which I have signed into Public Law No. 20-116:

Congressional Act No. 20-114, entitled: "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 19-10, AS AMENDED BY PUBLIC LAWS NOS. 19-26, 19-42, 19-51, 19-56, 19-72, 19-78, 19-96, 19-132, 19-163, 20-03, 20-25 AND 20-58 BY AMENDING SECTION 6 THEREOF, TO CHANGE THE LAPSE DATE OF FUNDS PREVIOUSLY APPROPRIATED THEREIN, FOR THE PURPOSE OF FUNDING PUBLIC PROJECTS AND SOCIAL PROGRAMS IN EACH OF THE STATES, AND FOR OTHER PURPOSES."

This act is extending the lapse date to September 30, 2019, of certain funds for public projects and social programs for the four FSM States appropriated by Congress in 2015. Thank you.

AN ACT

To further amend Public Law No. 19-10, as amended by Public Laws Nos. 19-26, 19-42, 19-51, 19-56, 19-72, 19-78, 19-96, 19-132, 19-163, 20-03, 20-25 and 20-58, by amending section 6 thereof, to change the lapse date of funds previously appropriated therein, for the purpose of funding public projects and social programs in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 6 of Public Law No. 19-10, as amended
- 2 by Public Laws Nos. 19-26, 19-42, 19-51, 19-78, 19-132 and 20-25
- 3 is hereby further amended to read as follows:

4	"Section 6. Allotment and management of funds and
5	lapse date. All funds appropriated by this act shall
6	be allotted, managed, administered and accounted for
7	in accordance with applicable laws, including, but not
8	limited to, the Financial Management Act of 1979. The
9	allottee shall be responsible for ensuring that these
10	funds, or so much thereof as may be necessary, are
11	used solely for the purpose specified in this act, and
12	that no obligations are incurred in excess of the sum
13	appropriated. The allottee of the funds appropriated
14	under section 2 of this act shall be the Governor of
15	Yap State; PROVIDED THAT, the allottee of funds
16	appropriated under subsection 2(h) of this act shall
17	be the President of COM-FSM. The allottee of funds

appropriated under sections 3 and 4 of this act shall
be the President of the Federated States of Micronesia
or his designee; PROVIDED THAT, the allottee of funds
appropriated under subsections 3(a), (b), (c), (d),
(e), (f), (g), (h), 9(i), (j) and (k) of this act
shall be the Mayor of Lelu Town Government; the
allottee of funds appropriated under subsections
4(2)(g) and 4(2)(h) shall be the Secretary of the
Department of Transportation, Communications and
Infrastructure; the allottee of funds appropriated
under subsections $4(3)(a)$, $4(3)(b)$ and $4(3)(d)$ of this
act shall be the Pohnpei Transportation Authority; and
the allottee of funds appropriated under subsections
4(3)(f) and 4(3)(h) of this act shall be the Pohnpei
Utility Corporation. The allottee of funds
appropriated under subsections $5(1)$, $5(3)$ and $5(6)$ of
this act shall be the Governor of Chuuk State or his
designee. The allottee of funds appropriated under
subsection 5(2) of this act shall be the Mortlock
Islands Development Authority. The allottee of funds
appropriated under subsection 5(4) of this act shall
be the Southern Namoneas Development Authority. The
allottee of funds appropriated under subsection 5(5)
of this act shall be the Faichuk Development
Authority. The authority of the allottee to obligate

1	funds appropriated by this act shall lapse on
2	September 30, 2019."
3	Section 2. This act shall become law upon approval by the
4	President of the Federated States of Micronesia or upon its
5	becoming law without such approval.
