AN ACT

To further amend section 12 of Public Law 19-118, as amended by Public Laws Nos. 19-125, 19-135, 20-01, 20-14, 20-23, 20-40, 20-46 and 20-74, to change the allottee for a certain line item for Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. Section 12 of Public Law No. 19-118, as amended 1
- by Public Laws Nos. 19-125, 19-135, 20-01 and 20-46, is hereby
- 3 further amended to read as follows:
- "Section 12. Allotment and Management of Funds and 4
- Lapse Dates. 5
- (1) General provisions. 6
- (a) All funds appropriated by this act shall be 7 allotted, managed, administered and accounted for in 8 accordance with applicable law, including, but not 9 limited to, the Financial Management Act of 1979. 10
- (b) The allottees shall be responsible for 11 ensuring that these funds, or so much thereof as may be 12 necessary, are used solely for the purposes specified in 13 this act, and that no obligations are incurred in excess 14 of the sums appropriated.
- (2) Allottees. The allottees of the funds 16 appropriated by this act are as follows: 17
- (a) Section 2 the allottee of these funds shall 18
