AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia (Annotated), as amended, by inserting a new section 1209 A, to vest all powers of the FSM Trust Fund Board of Directors in the President of the Federated States of Micronesia while the Board of the FSM Trust Fund is not constituted, subject to certain conditions, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 2 Micronesia (Annotated), as amended, is here by further amended by
- 3 inserting a new section 1209 A, to read as follows:
- "Section 1209 A: Interim Powers of the President. 4
- While the Board of the FSM Trust Fund, as defined by 5
- section 1208 of title 55 of the Code of the Federated 6
- States of Micronesia, has not been duly constituted 7
- and a majority of trustees not approved, all powers of 8
- the Board shall be vested in and exercisable by the 9
- President of the FSM; PROVIDED, HOWEVER, that the 10
- President shall require the Administrator of the Fund 11
- to report on a regular basis to Congress of the 12
- progress of the FSM Trust Fund. If the Administrator 13
- of the Fund is operating under the authority of this 14
- chapter in the administration of the fund, the 15
- Administrator shall be deemed a fiduciary and shall be 16
- held to the standard of a fiduciary. In the exercise 17
- of their duties under section 1209 and this section, 18

1	the President and the Administrator shall retain
2	competent investment advisors."
3	Section 2. This act shall become law upon approval by the
4	President of the Federated States of Micronesia or upon its
5	becoming law without such approval.
