CONGRESSIONAL BILL NO. 20-283, C.D.1

AN ACT

To further amend Public Law No. 19-121, as amended by Public Laws Nos. 19-130, 19-142, 19-145, 19-158, 20-09, 20-22, 20-51, 20-59, 20-70 and 20-123, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 19-121, as amended by
2 Public Laws Nos. 19-130, 19-142, 19-145, 20-22 and 20-51, is hereby
3 further amended to read as follows:

4 "Section 4. Of the sum of \$5,450,000 appropriated by
5 this act, \$1,200,000 is apportioned to fund public
6 projects and social programs for the people of the state
7 of Pohnpei.

11 Section 2. Section 6 of Public Law No. 19-121, as amended
 12 by Public Laws Nos. 19-130, 19-142, 20-09, 20-70 and 20-123, is
 13 hereby further amended to read as follows:

14 "Section 6. Allotment and management of funds and lapse
 15 date. All funds appropriated by this act shall be
 16 allotted, managed, administered and accounted for in
 17 accordance with applicable laws, including, but not
 18 limited to, the Financial Management Act of 1979. The
 19 allottee shall be responsible for ensuring that these
 20 funds, or so much thereof as may be necessary, are used
 21 solely for the purpose specified in this act, and that
 22 no obligations are incurred in excess of the sum
 23 appropriated. The allottee of the funds appropriated
 24 under section 2 of this act shall be the Governor of Yap
 25 State; PROVIDED THAT, the allottee of funds appropriated

1 under section 2(k) shall be the President of the
2 Federated States of Micronesia. The allottee of funds
3 appropriated under sections 3 and 4 of this act shall be
4 the President of the Federated States of Micronesia or
5 his designee; PROVIDED THAT the allottee of funds
6 appropriated under subsections 3(a) through 3(z) - shall
7 be the Mayor of Tafunsak Municipal Government; the
8 allottee of funds appropriated under subsections 3(aa) -
9 3(all) shall be the Mayor of Lelu Town Government, or
10 his designee; the allottee of funds appropriated under
11 subsections 4(1)(l), 4(3)(a), 4(3)(f) and 4(3)(i) of
12 this act shall be the Pohnpei Transportation Authority
13 (PTA); the allottee of funds appropriated under
14 subsections 4(2)(a), 4(2)(d), 4(2)(e), 4(2)(f), 4(2)(g),
15 4(2)(h), 4(2)(i), 4(2)(j), 4(2)(k), 4(2)(l) and 4(2)(m)
16 shall be the Secretary of the Department of
17 Transportation, Communications and Infrastructure or his
18 designee; the allottee of funds appropriated under
19 subsection 4(2)(b) shall be the Pohnpei Utility
20 Corporation (PUC); the allottee of funds appropriated
21 under subsection 4(2)(c) shall be the Office of
22 Fisheries, Pohnpei State; the allottee of funds
23 appropriated under subsection 4(2)(n) shall be the
24 Secretary of the Department of Education or his
25 designee; the allottee of funds appropriated under

subsection 4(3)(b) shall be the Pohnpei State Public Safety; the allottee of funds appropriated under subsections 4(3)(c) and 4(3)(e) of this act shall be the Meninkeder of Madolenihmw; allottee of funds appropriated under subsections 4(3)(d) and 4(3)(m) shall be the Luhkenmoanlap of Kittu. The allottee of funds appropriated under subsections 5(1), 5(3) and 5(6) of this act shall be the Governor of Chuuk State or his designee. The allottee of funds appropriated under subsection 5(2) of this act shall be the Mortlock Islands Development Authority. The allottee of funds appropriated under subsection 5(4) of this act shall be the Southern Namoneas Development Authority. The allottee of funds appropriated under subsection 5(5) of this act shall be the Faichuk Development Authority. The authority of the allottee to obligate funds appropriated by this act shall lapse on September 30, 2019."

1 Section 3. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.


