
Dear Speaker Simina:

CONGRESSIONAL BILL NO. 20-55, C.D.1

AN ACT

To further amend Public Law No. 19-124, as amended by Public Laws Nos. 19-133, 19-140, 19-150, 20-05 and 20-15, by amending sections 4 and 6 thereof, to change the use and allottee of some funds previously appropriated therein, to fund priority infrastructure projects and other programs in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 4. Section 4 of Public Law No. 19-124,  
2 as amended by Public Laws Nos. 19-133, 19-140, 20-05 and 20-15, is  
3 hereby further amended to read as follows:

25	Section 2. Section 6 of Public Law No. 19-124, as amended by	



1 Public Laws Nos. 19-133, 19-140, 20-05 and 20-15, is hereby  
2 further amended to read as follows:

3 "Section 6. Allotment and management of funds and lapse  
4 date. All funds appropriated by this act shall be  
5 allotted, managed, administered and accounted for in  
6 accordance with applicable laws, including, but not  
7 limited to, the Financial Management Act of 1979. The  
8 allottee shall be responsible for ensuring that these  
9 funds, or so much thereof as may be necessary, are used  
10 solely for the purpose specified in this act, and that  
11 no obligations are incurred in excess of the sum  
12 appropriated. The allottee of the funds appropriated  
13 under section 2 of this act shall be the Governor of the  
14 State of Yap or his designee. The allottee of the funds  
15 appropriated under sections 3 and 4 of this act shall be  
16 the President of the Federated States of Micronesia or  
17 his designee; PROVIDED THAT, the allottee of funds  
18 appropriated under subsections 3(1)(a) and 3(1)(b) of  
19 this act shall be the Governor of Kosrae State or his  
20 designee, the allottee of funds appropriated under  
21 subsections 4(1)(c) through 4(1)(o), 4(2)(f), 4(4)(b),  
22 4(4)(d), 4(4)(f), shall be the Pohnpei Transportation  
23 Authority (PTA); the allottee of funds appropriated  
24 under subsections 4(1)(a), 4(1)(b), 4(2)(c), 4(2)(d),  
25 4(2)(e), 4(2)(g), 4(2)(h), 4(2)(i), 4(2)(j) and sections

1 4(3)(a) to 4(3)(v) shall be the Secretary of the  
2 Department of Transportation, Communications and  
3 Infrastructure or his designee; the allottee of funds  
4 appropriatd under subsection 4(3)(aa) of this act shall  
5 be the Luhk en Moanlap of Kitti, the allottee of funds  
6 appropriated under subsection 4(3)(ad) of this act shall  
7 be the Chief Justice of Madolenihmw or his designee, the  
8 allottee of funds appropriated under subsection 4(3)(ae)  
9 of this act shall be the Chief Justice of Kitti or his  
10 designee. The allottee of the funds appropriated under  
11 section 5 of this act shall be the Governor of Chuuk  
12 State or his designee. The authority of the allottee to  
13 obligate funds appropriated by this act shall lapse on  
14 September 30, 2019.

1 Section 3. This act shall become law upon approval by the  
2 President of the Federated States of Micronesia or upon its  
3 becoming law without such approval.
