A BILL FOR AN ACT

To further amend Public Law No. 9-100, as amended, by further amending section 3, as amended by Public Laws Nos. 9-104, 9-137, and 9-158, to permit the use of certain funds for administrative costs, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 3 of Public Law No. 9-100, as
2	amended by Public Laws Nos. 9-104, 9-137, and 9-158 is
3	hereby further amended to read as follows:
4	"Section 3. The sum of \$4,347,000, or so much
5	thereof as may be necessary, is hereby
6	appropriated from the fiscal year ending
7	September 30, 1997, for the purpose of funding
8	the infrastructure, transportation, and
9	tourism development needs of the State of
10	Pohnpei. The funds appropriated under this
11	section shall be apportioned as follows:
12	(1) To fund infrastructure development
13	needs and purchase and operation of equipment for
14	transportation needs

16	(b) Election District no. 2
17	(i) Circumferential road 900,000

A BILL FOR AN ACT

To make Kim Young Po eligible for naturalization as a citizen of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 1. Kim Young Po, a citizen of Korea now 2 residing in Kosrae State, by virtue of his compliance with 3 the provisions of section 204 of title 7 of the Code of the 4 Federated States of Micronesia, is declared eligible for 5 Federated States of Micronesia citizenship, subject to 6 approval by the President of the Federated States of 7 Micronesia in the exercise of the power granted to him by 8 said section 204 of title 7 of the Code of the Federated 9 States of Micronesia. Section 2.
