CONGRESSIONAL BILL NO. 10-112

AN ACT

To further amend Public Law No. 7-107, as amended by Public Laws Nos. 7-133, 8-29, 9-031 and 9-148, by further amending section 3, as amended by Public Laws Nos. 7-133 and 9-031, by further amending section 4, as amended by Public Laws Nos. 7-133, 9-031 and 9-148, for the purpose of modifying the use of the funds appropriated to the Northwest Region and exempting it from the lapse date of Public Law No. 9-040, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 3 of Public Law No. 7-107, as amended by Public
2	Laws Nos. 7-133 and 9-031, is hereby further amended to read as follows:
3	"Section 3. The sum of \$600,000, or so much thereof as may be
4	necessary, is hereby appropriated from the General Fund of the
5	Federated States of Micronesia for the fiscal year ending
6	September 30, 1993, for funding small-scale fishing projects in
7	Chuuk State. The sum appropriated by this section shall be
8	apportioned as follows:
9	(1) Faichuk
10	(a) Wonei\$ 20,000
11	(b) Patta
12	(c) Polle
13	(d) Faichuk Fishing Cooperatives 85,000
14	(2) Southern Namoneas
15	(3) Mortlocks
16	(4) Northern Namoneas
17	(5) Northwest Region fishing grants 100,000"
18	Section 2. Section 4 of Public Law No. 7-107, as amended by Public
19	Laws Nos. 7-133, 9-031 and 9-148, is hereby further amended to read as
20	follows:
21	"Section 4. All funds appropriated by this act shall be
22	allotted, managed, administered, and accounted for in accordance

with applicable law, including, but not limited to, the 1 Financial Management Act of 1979. The allottee of the funds 2 appropriated under section 1 of this act shall be the President 3 of the Federated States of Micronesia or his designee. allottee of the funds appropriated under subsection (1) of 5 section 3 of this act shall be the Mayor of Polle. The allottee of the funds appropriated under subsections (2), (3) and (4) of section 3 of this act shall be the Chuuk Organization of 8 Community Agencies. The allottee of the funds appropriated 9 under subsection (5)(a) and (5)(b) of section 3 of this act 10 shall be the Northwest Islands Project Coordinator. The 11 allottees shall be responsible for ensuring that these funds, or 12 so much thereof as may be necessary, are used solely for the 13 purpose specified in this act, and that no obligations are 14 incurred in excess of the sum appropriated. Notwithstanding 15 Public Law No. 9-040, Tthe authority of the allottees to 16 obligate funds appropriated by this act shall not lapse." 17 Section 3. This act shall become law upon approval by the President 18 19 of the Federated States of Micronesia or upon its becoming law without such
