A BILL FOR AN ACT

To further amend Public Law No. 8-93, as amended, by further amending section 1, as amended by Public Laws Nos. 8-98, 9-098 and 10-47, to allow funds appropriated therein to be used for water tanks, water catchments, and other public projects necessary for the preparation for or adjustment to changing weather patterns or climatic conditions, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 1 of Public Law No. 8-93, as amended by Public Laws
2	Nos. 8-98, 9-098, and 10-47, is hereby further amended to read as follows:
3	"Section 1. The sum of \$1,300,000, or so much thereof as may be
4	necessary, is hereby appropriated from the General Fund of the
5	Federated States of Micronesia for the fiscal year ending
6	September 30, 1995, for school needs and for the purpose of
7	funding needs relating to the acquisition, installation or
8	construction of water tanks and water catchments, and for other
9	public projects necessary for the preparation for or adjustment
10	to changing weather patterns or climatic conditions throughout
11	the Federated States of Micronesia. The funds appropriated under
12	this act shall be apportioned as follows:
