## A BILL FOR AN ACT

To amend Public Law No. 10-72, by amending section 6, to provide that the Board of Directors of Caroline Islands Air, a public corporation, shall be composed of five members, including the Secretary of Transportation, Communication and Infrastructure and four other members appointed by the President, and for other purposes.
