A BILL FOR AN ACT

To further amend Public Law No. 9-027, as amended by Public Laws Nos. 9-083, 9-113 and 10-65, by further amending section 1 thereof, as amended by Public Law No. 9-113, for the purpose of reallocating and modifying the use of funds appropriated therein, and by further amending section 5, as amended by Public Laws Nos. 9-083 and 10-65, to change the allottee of certain funds appropriated for medical supplies, equipment, referral programs, and construction, renovation and operations of dispensaries in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

16	Section 2. Section 5 of Public Law No. 9-027, as amended by Public Laws

19	managed, administered, and accounted for in accordance with					
20	applicable law, including, but not limited to, the Financial					
21	Management Act of 1979. All funds appropriated herein shall not					
22	lapse until fully expended. The allottee of the funds appropriated					
23	under subsection (1) of section 1 of this act shall be the [Director

10	the funds appropriated under subsection (6) of section 1 of this
11	act shall be the Pattiw Development Authority. The allottee of the
12	funds appropriated under section 2 of this act shall be the
13	Governor of Pohnpei State. The allottee of the funds
14	appropriated under section 3 of this act shall be the Governor of
15	Yap State. The allottee of the funds appropriated under section
16	4 of this act shall be the Governor of Kosrae State. The allottees
17	shall be responsible for ensuring that these funds, or so much
18	thereof as may be necessary, are used solely for the purpose
19	specified in this act, and that no obligations are incurred in excess
20	of the sum appropriated."
21	Section 3. This act shall become law upon approval by the President of the
22	Federated States of Micronesia or upon its becoming law without such approval.
