PUBLIC LAW NO. 10-071

## AN ACT

To further amend Public Law No. 5-89, as amended, by further amending section 6, as amended by Public Laws Nos. 5-99, 5-126, 6-47, 6-78, 7-56, and 7-131, to modify the use of funds appropriated therein for Chuuk State public projects, and by further amending section 8, as amended by Public Laws Nos. 5-99, 7-2, 7-56, 8-62, and 9-034 to change the allottee of funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 6 of Public Law No. 5-89, as amended by Public Laws Nos. 5-99, 5-126, 6-47, 6-78, 7-56, and 7-131, is hereby further amended to read as follows:

"Section 6. Halls, Western Islands and Namonwitto public projects. The sum of \$200,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1989, for the purpose of funding certain public projects and for the purchase of fuel in the Halls, Western Islands and Namunweito, Chuuk State. The sum appropriated by this section shall be apportioned as follows:

- (1) Hall Islands Development Authority..... \$ 10,000
- (2) Weito Islands Development Authority (WDA)
  - (a) Purchase and maintenance of dump truck..... -0-
  - (b) WDA office extension..... -0-
  - (c) WDA purchase of boat.....--0-

Section 2. Section 8 of Public Law No. 5-89, as amended by Public Laws Nos. 5-99, 7-2, 7-56, 8-62, and 9-034 is hereby further amended to read as follows:

"Section 8. Allotment and management of funds and lapse date. All funds appropriated by this act shall be allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated under sections 1, 2 and 3 of this act shall be the Governor of Chuuk State, except for the funds appropriated by sub-paragraph (1)(d) of section 1 for which the allottee shall be the Chuuk State Congressional Delegation; by sub-paragraph (2) of section 1 for which the allottee shall be the Executive Director of the Chuuk Maritime Authority; and by sub-paragraph (3) of section 1 for which the allottee shall be the Executive Director of the Chuuk Organization of Community Action. The allottee of the funds appropriated under sub-paragraph (11) of section 2 of this act shall be the Northern Namoneas Development Authority. The allottee of the funds appropriated under sections 4 and 7 of this act and under subsections (5) and (6) of section 5 of this act, and under subsections (4)(a)(i), (4)(b)(i), (4)(c)(i) and (4)(d)(i) of section 6 of this act shall be the Chairman of the Chuuk State Congressional Delegation. The allottee of all other funds appropriated under section 5 of this act shall be the Lower Mortlocks Development Authority. The allottee of the funds

appropriated under sub-paragraph (1) and subsections (4)(a)(ii), (4)(b)(ii), (4)(c)(ii), (4)(d)(ii) and (4)(e) of section 6 of this act shall be the Hall Islands Development Authority. The allottee of the funds appropriated under sub-paragraphs (2) and (5) of section 6 of this act shall be the Nomunweito Project Coordinator. The allottee of the funds appropriated under subparagraphs (3) and (6) of section 6 of this act shall be the Pattiw Islands Development Authority. The allottee of the funds appropriated under sub-paragraph (7) of section 6 of this act shall be the Board of Directors of the Nomwin Co-op. Each allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum appropriated. The authority of the allottees to obligate funds appropriated by this act shall not lapse."

Section 3. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
