AN ACT

To appropriate the sum of \$2,992,468 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1999, for the purpose of funding certain FSM projects and health, education, infrastructure and other public projects and programs in the States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. The sum of \$1,041,718 or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1999, for the purpose of funding certain national projects and programs. The funds appropriated herein shall be apportioned as follows:

- (1) March, 1999, CFSM elections......\$ 300,000 (2) JCN supplemental funding.....
- 200,000
 - (3) National Fisheries Corporation subsidy.... 250,000
- (4) Mortlocks airport paving/soil cement
 (which shall be deemed to come from the capital account,
 section 211 of the Compact of Free Association)...... 200,000
- (5) Other expenses of National Government programs
- - (b) Overtime, 2nd FSM Games......23,000
- (c) Expenses for housing of athletes,
- - (d) President's Office travel...... 23,000
- (6) Micronesian Red Cross subsidy (funds appropriated herein shall be deemed to come from funds available under section 221(b) of the Compact of Free Association)\$ 22,718

Section 2. The sum of \$750,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1999, for the purpose of funding health, education, infrastructure and other public projects and programs in the State of Chuuk. The funds appropriated herein shall be apportioned as follows:

(5) Chuuk Hospital - medical supplies...... 100,000

Section 3. The sum of \$650,750, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1999, for the purpose of funding health, education, infrastructure and other public projects and programs in the State of Pohnpei. The funds appropriated under subsection (1) of this section shall be deemed to come from the communication operations and maintenance account, section 215(a)(2) of the Compact of Free Association. The funds appropriated herein shall be apportioned as follows:

- (1) Department of Public Safety, Pohnpei

 State communication equipment......\$50,750
- (2) Other health, education, infrastructure and other public projects and programs................600,000

Section 4. The sum of \$350,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1999, for the purpose of funding health, education, infrastructure and other public projects and programs in the State of Yap. The funds appropriated herein shall be apportioned as follows:

(2)	Wottegai Elementary School Building 45,000
(3)	Rumuu Elementary School
(4)	Falalop, Ulithi Elementary School 25,000

Section 5. The sum of \$200,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1999, for the purpose of funding shoreline erosion protection, health, education, infrastructure and other projects and grants in the State of Kosrae. The funds appropriated under this section shall be apportioned as follows:

(1) Lelu shoreline protection.....\$

(3) Utwe shoreline protection

Section 6. All funds appropriated by this act shall be allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated under section 1(2) of this act shall be the Chairman of the Joint Committee on Compact Economic Negotiations, or his designee. allottee of the funds appropriated under section 1(4) of this act shall be the Secretary of the Department of Transportation, Communication and Infrastructure. The allottee of the funds appropriated under section 2(1) of this act shall be the Executive Director of the Southern Namoneas Development Authority. If the Southern Namoneas Development Authority shall be abolished pursuant to Chuuk State law, the Southern Namoneas Development Authority shall be deemed to be, and shall be treated as, a continuing entity for the purposes of this measure. The allottee of the funds appropriated under section 2(2) of this act shall be the Mayor of_Polle. The allottee of the funds

appropriated under section 2(3) of this act shall be the Executive Director of the Northern Namoneas Development Authority, or if the Northern Namoneas Development Authority shall be abolished, the Northern Namoneas Project Coordinator or his designee. The allottee of the funds appropriated under section 2(4) of this act shall be the Northwest Islands Project Coordinator or his designee. The allottee of the funds appropriated under section 2(5) of this act shall be the Secretary of the Department of Health, Education and Social Affairs of the Federated States of Micronesia, or his designee. The allotte of the funds appropriated under section 3(1) of this act shall be the Secretary of the Department of Justice of the Federated States of Micronesia. The allottee of the funds appropriated under section 4 of this act shall be the Governor of the State of Yap. The allottee of the funds appropriated under section 5 of this act shall be the Governor of the State of Kosrae. The allottee of all other funds appropriated by this act shall be the President of the Federated States of Micronesia or the President's designee. The allottees shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum appropriated. The authority of the allottees to obligate funds appropriated under section 1(1) to 1(3) and 1(5) of this act shall lapse as of September 30, 1999. The authority of the allottees to obligate all other funds appropriated by this act shall lapse as of September 30, 2000.
