

ELEVENTH CONGRESS OF THE FEDERATED STATES OF MICRONESIA

FIRST REGULAR SESSION, 1999 CONGRESSIONAL BILL NO. 11-11, C.D.1, C.D.2, C.D.3, C.D.4, C.D.5, C.D.6

AN ACT

To appropriate the sum of \$6,750,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2000, for the purpose of funding infrastructure projects, roads, and other economic and social projects and programs in the States of Chuuk, Kosrae, Pohnpei and Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. The sum of \$3,000,000, or so much thereof as may be							
2	2 necessary, is hereby appropriated from the General Fund of the							
3	Federated States of Micronesia for the fiscal year ending September							
4	30, 2000, for the purpose of funding infrastructure projects, roads							
5	and other economic and social projects and programs in the State of							
6	Chuuk. The funds appropriated under this section shall be							
7	7 apportioned as follows:							
8	(1) Chuuk state-wide projects \$ 100,000							
9	(2) Election District No. 1 650,000							
10	(3) Election District No. 2 650,000							
11	(4) Election District No. 3 650,000							
12	(5) Election District No. 4 650,000							
13	(6) Election District No. 5 300,000							
14	Section 2. The sum of \$2,000,000, or so much thereof as may be							
15	necessary, is hereby appropriated from the General Fund of the							
16	Federated States of Micronesia for the fiscal year ending September							
17	30, 2000, for the purpose of funding infrastructure projects, roads,							
18	and other economic and social projects and programs in the State of							
19	Pohnpei. The funds appropriated under this section shall be							
20	apportioned as follows:							
21	(1) Election District No. 1 \$ 750,000							
22	(2) Election District No. 2 650,000							

(3) Election District No. 3 \$ Section 3. The sum of \$1,000,000, or so much thereof as may be 3 necessary, is hereby appropriated from the General Fund of the 4 Federated States of Micronesia for the fiscal year ending September 30, 2000, for the purpose of funding infrastructure projects, roads, and other economic and social projects and programs in the State of 7 Yap. Section 4. The sum of \$750,000, or so much thereof as may be 9 necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 10 30, 2000, for the purpose of funding infrastructure projects, roads, 11 12 and other economic and social projects and programs in the State of 13 Kosrae. Allotment and management of funds and lapse date. 14 Section 5. (1) All funds appropriated by this act shall be allotted, 15 16 managed, administered, and accounted for in accordance with 17 applicable law, including, but not limited to, the Financial 18 Management Act of 1979. The allottee of the funds appropriated by 19 section 1 of this act shall be the Executive Director of Chuuk State 20 Commission on Improvement Projects, or his designee. The allottee 21 of all other funds appropriated by this act shall be the President 22 of the Federated States of Micronesia or the President's designee. 23 The allottees shall not obligate funds appropriated under this act 24 without consultation and agreement on the most appropriate usage of 25 said funds between allottee and the relevant Congressional

1	Delegation. The allottees shall be responsible for ensuring that						
2	these funds, or so much thereof as may be necessary, are used solely						
3	for the purpose specified in this act, and that no obligations are						
4	incurred in excess of the sum appropriated.						
5	(2) The authority of the allottees to obligate funds						
6	appropriated by this act shall lapse as of September 30, 2001.						
7	Section 3. This act shall become law upon approval by the						
8	President of the Federated States of Micronesia or upon its becoming						
9	law without such approval.

A BILL FOR AN ACT

To appropriate the sum of \$10,000,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2000, for the purpose of funding infrastructure projects in the States of Chuuk, Kosrae, Pohnpei and Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$10,000,000, or so much thereof as may
- 2 be necessary, is hereby appropriated from the General Fund of the
- 3 Federated States of Micronesia for the fiscal year ending September
- 4 30, 2000, for the purpose of funding infrastructure projects in the
- 5 States of Chuuk, Kosrae, Pohnpei and Yap.
- 6 Section 2. Allotment and management of funds and lapse date.
- 7 (1) All funds appropriated by this act shall be allotted,
- 8 managed, administered, and accounted for in accordance with
- 9 applicable law, including, but not limited to, the Financial
- 10 Management Act of 1979. The allottee of the funds appropriated by
- 11 this act shall be the President of the Federated States of
- 12 Micronesia or the President's designee. The allottee shall be
- 13 responsible for ensuring that these funds, or so much thereof as may
- 14 be necessary, are used solely for the purpose specified in this act,
- 15 and that no obligations are incurred in excess of the sum
- 16 appropriated.
- 17 (2) The authority of the allottee to obligate funds
- 18 appropriated by this act shall lapse as of September 30, 2001.
- 19 Section 3. This act shall become law upon approval by the
- 20 President of the Federated States of Micronesia or upon its becoming
- 21 law without such approval.
