A BILL FOR AN ACT

To further amend Public Law No. 10-119, as amended, by further amending section 2, as amended by Public Laws Nos. 10-128 and 10-138, to appropriate \$66,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1999, for the purpose of funding repairs and renovation of the Speaker's residence in Nanpohnmal, Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 2 of Public Law No. 10-119, as amended by
2	Public Laws Nos. 10-128 and 10-138, is hereby further amended to
3	read as follows:
4	"Section 2. Operating expenses of the Legislative
5	Branch. The sum of $\{\frac{3,093,745}{3,159,745}$, or so much
6	thereof as may be necessary, is hereby appropriated from
7	the General Fund of the Federated States of Micronesia
8	for the fiscal year ending September 30, 1999, for the
9	operations of the Legislative Branch of the National
10	Government of the Federated States of Micronesia during
11	fiscal year 1999. The sum appropriated by this section
12	shall be apportioned as follows:
