A BILL FOR AN ACT

To further amend Public Law No. 10-120, as amended by Public Laws Nos. 10-122, 10-144, 11-5 and 11-8, by further amending section 3, as amended by Public Law No. 10-122, and by further amending section 6, as amended by Public Laws Nos. 10-122 and 11-8, to provide a further apportionment of funds and to change an allottee, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 3 of Public Law No. 10-120, as amended by
2	Public Law No. 10-122, is hereby further amended to read as follows:
3	"Section 3. The sum of \$3,000,000, or so much thereof as
4	may be necessary, is hereby appropriated from the General
5	Fund of the Federated States of Micronesia for the fiscal
6	year ending September 30, 1999, for the purpose of
7	funding infrastructure and other projects and programs in
8	the State of Pohnpei. The funds appropriated herein
9	shall be apportioned as follows:
10	(1) Election District No. 1
11	(a) Kolonia Town paving \$ 220,275
12	(b) Other projects 679,725
13	(2) Election District No. 2 800,000
14	(3) Election District No. 3 700,000
15	(4) Statewide projects 600,000"
16	Section 2. Section 6 of Public Law No. 10-120, as amended by
17	Public Laws Nos. 10-122 and 11-8, is hereby further amended to read
18	as follows:
19	"Section 6. Allotment and management of funds and lapse
20	date.
21	(1) All funds appropriated by this act shall be
22	allotted, managed, administered, and accounted for in
23	accordance with applicable law, including, but not
24	limited to, the Financial Management Act of 1979. The
25	allottee of the funds appropriated under section 1(3)(e)

of this act shall be the Governor of the State of Chuuk or his designee. The allottee of the funds appropriated under section 1(2) of this act shall be the Speaker of the Congress of the Federated States of Micronesia. The allottee of the funds appropriated under section 1(3)(a) of this act shall be the Director of the Department of Health Services. The allottee of the funds appropriated under section 1(3)(c) of this act shall be the Assistant Director, Land Grant Program, Cooperative Extension Services, Chuuk State. The allottee of the funds appropriated under section 1(3)(d) of this act shall be the Executive Director of the Chuuk Recreation Office. The allottee of the funds appropriated under sections 1(3)(f) and 1(3)(g) of this act shall be the Secretary of the Department of Health, Education and Social Affairs of the Federated States of Micronesia, or his designee. allottee of the funds appropriated under section 1(4) of this act shall be the Mortlocks Development Authority, or if the Mortlocks Development Authority shall be abolished, the Project Coordinator for the Mortlocks or his designee. The allottee of the funds appropriated under sections 1(5) and 1(3)(b) of this act shall be the Executive Director of the Northern Namoneas Development Authority, or if the Northern Namoneas Development Authority shall be abolished, the Northern Namoneas

Project Coordinator or his designee. The allottee of the
funds appropriated under section 1(6) of this act shall
be the Executive Director of the Southern Namoneas
Development Authority. If the Southern Namoneas
Development Authority shall be abolished pursuant to
Chuuk State law, the Southern Namoneas Development
Authority shall be deemed to be, and shall be treated as
a continuing entity for the purposes of this measure.
The allottee of the funds appropriated under section 1(7)
of this act shall be the Mayor of Polle. The allottee of
the funds appropriated under section 1(8)(a) of this act
shall be the Northwest Islands Project Coordinator or his
designee. The allottee of the funds appropriated under
section 1(8)(b) of this act shall be the General Manager,
Northwest Financial Services. The allottee of the funds
appropriated under section 2(1) of this act shall be the
respective mayor of each municipality listed therein.
The allottee of the funds appropriated under sections
2(2) through 2(8) of this act shall be the Governor of
the State of Kosrae. The allottee of the funds
appropriated under section 2(9) of this act shall be the
President of the Federated States of Micronesia, or the
President's designee. The allottee of the funds
appropriated under section 3(1)(a) of this act shall be
the Mayor of Kolonia Town. The allottee of the funds

1	appropriated under sections 4(1) through 4(7) and 4(9)
2	through 4(18) of this act shall be the Governor of the
3	State of Yap. The allottee of the funds appropriated
4	under section 4(8) of this act shall be the Speaker of
5	the Congress of the Federated States of Micronesia. The
6	allottee of all other funds appropriated by this act
7	shall be the President of the Federated States of
8	Micronesia or the President's designee. In the event
9	that the President designates the Vice President as
10	allottee, the Vice President may designate a suballottee.
11	The allottees shall be responsible for ensuring that
12	these funds, or so much thereof as may be necessary, are
13	used solely for the purpose specified in this act, and
14	that no obligations are incurred in excess of the sum
15	appropriated. No allottee of funds appropriated under
16	section 2(1) of this act shall obligate funds without
17	first consulting with the members of the Kosrae
18	delegation to the Congress of the Federated States of
19	Micronesia. The allottee of funds [set aside for
20	projects in Pohnpei Election District No. 2] under
21	section 3(2) of this act shall not obligate funds without
22	first consulting with the member of the Congress of the
23	Federated States of Micronesia representing that
24	district, and said allottee shall obligate no more than
25	ten percent of such funds for administrative costs.

(2) The authority of the allottees to obligate funds appropriated by this act shall lapse as of September 30, 2001." Section 3. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval. Date: 7-13-99 Introduced by:
