A BILL FOR AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia, as amended, by repealing section 102 and enacting a new section 102; by repealing section 103 and enacting a new section 103; by enacting new sections 103A to 103G; by repealing section 106 and enacting a new section 106; by enacting new sections 106A to 106D; by enacting a new section 201A; by amending section 202; by repealing section 204 and enacting a new section 204; by enacting new sections 205A to 205G; by repealing section 215 and renumbering sections 216 to 223 as sections 215 to 222; by enacting a new section 223; by enacting new sections 223A to 223D; by repealing sections 225 and 226; and by enacting a new section 226; for the purpose of enhancing effective and sponsible management by government; and for other purposes

res	ponsible management by government; and for other purposes.
BE	IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Purpose. The purposes of the amendments contained
2	herein are to foster and enhance effective and responsible economic
3	and fiscal management by government, including adherence to policy;
4	and to provide enhanced accountability arrangements; thereby
5	requiring the Executive to produce:
6	(1) statements of proposed policy;
7	(2) confirmation of adherence to fiscal disciplines;
8	(3) economic and fiscal statements, including economic
9	and fiscal forecasts and updates; and
10	(4) financial management information, including
11	comprehensive annual reports.
12	Section 2. Section 102 of title 55 of the Code of the
13	Federated States of Micronesia is hereby repealed in its entirety
14	and a new section 102 is hereby enacted to read as follows:
15	"Section 102. Definitions. In this title, unless
16	otherwise expressly provided and unless the context
17	otherwise requires:
18	(1) 'Agency' or 'Agencies' means any agency,
19	commission, authority, board, bureau, or other
20	organization of the National Government established by
21	law and not specifically part of one of the three
22	branches of the National Government.
23	(2) 'Allotment' means the delegation of authority to a

1	person to create legally enforceable financial
2	obligations in accordance with applicable law on behalf
3	of the Federated States of Micronesia, within specified
4	limits set forth in an appropriation act of the
5	Federated States of Micronesia or as may be required by
6	the terms of funding available from other sources.
7	(3) 'Allot' means to make an allotment.
8	(4) 'Allottee' means any person or entity to whom an
9	allotment is made.
10	(5) 'Annual budget proposal' means the annual request
11	for new obligation and expenditure authority during the
12	ensuing fiscal year by all branches and agencies of the
13	National Government for all purposes, including but not
14	limited to, Government operations, development programs
15	and projects, special programs, contributions, grants
16	and subsidies.
17	(6) 'Appropriation' or 'appropriation act'
18	means a law enacted by Congress which authorizes the
19	National Government to incur obligations and make
20	payments out of the National Treasury in accordance with
21	law.
22	(7) 'Borrowing' means money loaned to the National
23	Government and not required to be repaid in full within
24	the current fiscal year and 'borrowing expenses' are
25	expenses related to such a borrowing.

1	(8) 'Congress' means the Congress of the Federated
2	States of Micronesia.
3	(9) 'Department' means a department or office.
4	(10) 'Fiscal year' means the twelve month period from
5	October 1 of one calendar year through September 30 of
6	the succeeding calendar year.
7	(11) 'FSM' means the Federated States of Micronesia.
8	(12) 'Head of department' or 'department head' means a
9	secretary or head of a department or agency, however
10	called.
11	(13) 'National Government' means the department and
12	offices of the executive branch, Congress, the judicial
13	branch and agencies of the National Government.
1.4	(14) 'Output' and 'outcome' means the production of
15	goods and services by a department, Congress, the
16	judicial branch, agency of the National Government or an
17	allottee.
18	(15) 'Person' means any natural person, company,
19	corporation, partnership, trust, incorporated or
20	unincorporated society, charitable body, or other
21	organization or entity recognized by law.
22	(16) 'Public funds' means all the funds, resources and
23	entitlements owned by, owed to, or held by the National
24	Government, or held by any person for or on behalf of
25	the National Government, and includes public resources.

1	(17) 'Public resources' means real or personal property
2	that is the property of the National Government, and
3	includes public funds.
4	(18) 'Secretary' or 'Secretary of Finance' means the
5	Secretary of Finance and Administration or his
6	successor."
7	Section 3. Section 103 of title 55 of the Code of the
8	Federated States of Micronesia is hereby repealed in its entirety
9	and a new section 103 is hereby enacted to read as follows.
10	"Section 103. Annual budget.
11	(1) No later than June 30 of each year, the President
12	shall submit to the Congress the annual budget proposal
13	for the National Government for the ensuing fiscal year.
14	The annual budget proposal shall contain a statement of
15	anticipated revenues from all sources, details of
16	operations and development expenditures, and planned
17	expenditures for all sources of funds.
18	(2) The annual budget proposal shall be in a form that
19	will provide for a separate appropriation for each
20	department, Congress, the judicial branch, and agencies
21	of the National Government for each of the following
22	<pre>categories:</pre>
23	(a) each category of output;
24	(b) each category of benefits, grants or
25	subsidies;

1	(c) each category of borrowing expenses or
2	repayment of debts;
3	(d) each category of other non-operating
4	expenses; and
5	(e) each category of capital acquisitions or
6	capital contributions.
7	(3) The authority to expend cash or incur expenses or
8	obligations under an appropriation act will lapse at the
9	end of the fiscal year to which that act relates but any
L 0	unexpended balance of any appropriation may be dealt
1	with in accordance with this act.
.2	(4) The President shall submit the following with the
1.3	annual budget proposal:
4	(a) a budget message, which shall include such
15	supporting financial, statistical, output performance,
.6	and other information, data and recommendations as the
L7	President may determine are in the public interest and
L8	consistent with the principles of fiscal responsibility
L 9	set out in section 201A of this title;
20	(b) proposed legislation to appropriate funds for
21	the National Government for the ensuing fiscal year,
22	reflecting the President's recommendations as contained
23	in the proposed budget and in accordance with the
24	requirements specified under section 106A of this title;
25	(c) a statement, including forecasts, providing a

14	2	set forth in section 201A of this title, particularly,
15	3	and in title 55, generally."
16	Section	4. Title 55 of the Code of the Federated States of
17	Micronesia,	as amended, is hereby further amended by enacting a new
18	section 103A	to read as follows:
19		Section 103A. Fiscal strategy report.
20		(1) The President shall submit to Congress, at the
21	<u> </u>	same time as, and in addition to the annual budget
22	Ī	proposal, a report on the Executive's fiscal strategy.
23		(2) The fiscal strategy report shall:
24		(a) include an assessment of the extent to which
25	<u>t</u>	the annual budget proposal is consistent with the

3	(b) include an explanation of the reasons for any
4	significant differences between the current economic and
5	financial situation of the National Government and the
6	information and intentions presented in the previous

9	(c) where the circumstances have changed, present
10	an amended set of intentions;
11	(d) provide projections of movements in the
12	variables specified in sections 103F and 103G of this
13	title which demonstrate intended progress towards
14	achieving the longer term objectives specified in the
15	economic and fiscal policy statement most recently
16	published and state the significant assumptions on which
17	the projections are based."
18	Section 5. Title 55 of the Code of the Federated States of
19	Micronesia, as amended, is hereby further amended by enacting a new
20	section 103B to read as follows:
21	"Section 103B. Economic and fiscal policy statement.
22	(1) The President shall submit to Congress and
23	publish, not later than March 31 of each year, an
24	economic and fiscal policy statement for the fiscal year
25	commencing on October 1 after publication, and forecasts

1	for the two years following that fiscal year and this
2	economic and fiscal policy statement shall:
3	(a) specify the economic and fiscal policy that
4	the executive branch and agencies will follow in all
5	economic and fiscal dealings, and disciplines that each

8	term fiscal policy objectives and in particular, provide
9	for the principle variables specified in sections 103F
10	and 103G of this title;
11	(c) specify the broad strategic priorities by

3		priorities, and intentions referred to under subsection
4		(1) of this section with the objectives, priorities, and
5		intentions indicated in the immediately preceding
6		economic and fiscal policy statement; or, if amended,
7		the amended statement and, where these are not
8		consistent, justify the departure.
9		(3) Any member of the public may, within twenty-eight
10		days of the economic and fiscal policy statement being
11		published, deliver in writing to the office of the
12		President any submission that person may have in respect
13		of that statement. The President shall consider any
14		submission made in accordance with this section."
15	Section	n 6. Title 55 of the Code of the Federated States of
16	Micronesia,	as amended, is hereby further amended by enacting a new
17	section 1030	C to read as follows:
18		"Section 103C. Economic and fiscal update.
19		(1) The President shall, no later than October 1 in
20		each fiscal year, publish a report updating the economic
21		and fiscal policy statement for the fiscal year
22		beginning from that day.
23		(2) The economic and fiscal update report shall
24		contain:
25		(a) an economic and fiscal update for the current

11	The Congress, the judicial branch, and agencies shall
12	transmit to the President, no later than June 1 of each
13	year, details of planned operational and development
14	expenditures and projected revenue. The Congress, the
15	judicial branch, and agencies shall also transmit budget
16	projections for each of the two subsequent fiscal years
17	and such other information as may be required by law.
18	The President shall include such planned expenditures,
19	projected revenue, and budget projections in the annual
20	budget proposal without revision, and subject to his or
21	her recommendations."
22	Section 8. Title 55 of the Code of the Federated States of
23	Micronesia, as amended, is hereby further amended by enacting a new
24	section 103E to read as follows:
25	"Section 103E. Information to be supplied by

1	governments, entities and others.
2	Each State Government, municipality, or other governmen
3	organization or official who seeks National Government
4	funds for development programs or projects shall
5	transmit to the President, no later than June 1 of each
6	year, planned developmental expenditures for the ensuin
7	fiscal year. State Governments shall also transmit a
8	statement of the State's general economic and fiscal
9	plan, including a priority schedule of the development
10	projects the State plans to undertake and the reasons
11	therefor; developmental budget projections for each of
12	the two subsequent fiscal years; and such other
13	information as may be required by law. The President
14	shall include such planned expenditures, economic and
15	fiscal plans, and budget projections in the annual
16	budget proposal, without revision, but subject to his c

18	Section 9. Title 55 of the Code of the Federated States of
19	Micronesia, as amended, is hereby further amended by enacting a new
20	section 103F to read as follows:
21	"Section 103F. Economic and fiscal data.
22	(1) Economic reports required under chapters 1 and 2
23	of title 55 shall include forecasts depicting movements
24	in the Federated States of Micronesia of:
25	(a) gross domestic product, including the major

9	(2) Fiscal forecasts required under chapters 1 and 2

11	(a) forecast information with respect to the

14	current fiscal year update and comparative budgeted and
15	actual figures for the fiscal year immediately preceding
16	the first of the fiscal years to which the fiscal
17	forecast relates; and
18	(c) details of fiscal risks and, where they
19	cannot be quantified, a description of possible impacts.
20	(3) Economic forecasts shall include a statement of
21	all significant assumptions underlying them."
22	Section 10. Title 55 of the Code of the Federated States of
23	Micronesia, as amended, is hereby further amended by enacting a new
24	section 103G to read as follows:
25	"Section 103G. Reporting requirements.

1	(1) Any forecast or statement required under
2	chapters 1 and 2 of title 55 shall include details of:
3	(a) the total operating expenditures;
4	(b) the total benefits, grants or
5	subsidies;
6	(c) all other expenditures;

8	(e) all other revenue;
9	(f) the difference between all expenditure and
10	all revenue;
11	(g) the level of total debt; and
12	(h) the level of asset holdings.
13	(2) Each report shall also include:
14	(a) a statement of financial position;

17	(d) a statement of borrowings;

16		(4) The budget alteration authority of Congress shall
17		be executed by means of appropriation legislation.

21		(5) Congress may restrict, by law, the expenditure of
22		funds for a specific purpose.
23		(6) Notwithstanding section 217 of this title and
24		unless otherwise specified by law:
25		(a) appropriations of National Government funds

1		for National Government development projects shall be
2		allotted through the President or the Governor of the
3		State where the project is being undertaken;
4		(b) appropriations of National Government funds
5		for non-National Government development projects shall
6		be allotted through the Governor of the State where the
7		project is being undertaken; and
8		(7) The President, or the Governor, as the case may
9		be, may only obligate funds where he or she is satisfied
10		that the project is in accordance with the
11		appropriation, is planned with realistic estimates of
12		proposed expenditures, and shall release funds where
13		appropriate, by progress payments, upon obtaining
14		satisfactory evidence of the obligation to incur such
15		expenditure.
16		(8) If Congress does not appropriate National
17		Government funds through the President or Governor in
18		accordance with subsection (6) of this section, it shall
19		record in the Congress journal or in a committee report
20		the reasons for the departure and, shall record the
21		details of the project, the project plan, and the result
22		intended to be achieved, and ensure that the
23		appropriation act reflects those details."

25	Micronesia,	as amended, is hereby further amended by enacting a new

24	(1) A department head may, from time to time, make
25	transfers between outputs where:

1		(a) the transfer does not conflict with
2		performance of the outputs specified in the budget
3		policy;
4		(b) the total appropriation for that fiscal year
5		for that department is unaltered.
6		(2) The department head must advise the Secretary who
7		shall ensure that sufficient details to explain any
8		transfer made pursuant to subsection (1) of this section
9		will be included in a report to the President.
10		(3) The President may reprogram up to ten percent to
11		and from the funds appropriated to each department and
12		office in the annual budget act, after first specifying
13		the outputs for which funding is either increased or
14		decreased."

16	Micronesia,	as amended, is hereby further amended by enacting a new
17	section 106	5C to read as follows:
18		"Section 106C. Net appropriations.
19		(1) An appropriation may be shown in the appropriation
20		act to be off-set by an amount of revenue where that
21		revenue applies to the recovery costs of the relevant
22		budget output and meets the criteria set for that output
23		by the Secretary.
24		(2) Where an appropriation is for a net appropriation,
25		all estimated expenditures and revenue, from all

8	unexpended appropriations.
9	Where provision has been made in any appropriation act
10	for expenditure, but that expenditure was not incurred
11	during the fiscal year to which the act relates, the
12	President may, after consultation with the Cabinet,
13	direct that the unexpended amount, or a portion thereof,
14	be reappropriated for the next fiscal year to the
15	department or government agency that did not expend the
16	amount appropriated to it for expenditure in accordance
17	with the outputs specified in the original
18	appropriation."
19	Section 16. Title 55 of the Code of the Federated States of
20	Micronesia, as amended, is hereby further amended by enacting a new
21	section 201A to read as follows:
22	"Section 201A. Fiscal responsibility.
23	(1) The National Government shall pursue its policy
24	objectives in accordance with the principles of
25	responsible fiscal management specified in subsection

2		(2) The principles of responsible fiscal management
3		are:
4		(a) managing and keeping the total debt at such
5		levels that a balanced budget is achieved;
6		(b) achieving and maintaining levels of FSM net

8		adversely impact the FSM's net worth in the future;
9		(c) prudently managing the fiscal risks facing
10		the FSM; and
11		(d) pursuing policies that are consistent with a
12		reasonable degree of predictability about the level and
13		stability of tax rates for future years."
14	Sectio	on 17. Section 202 of title 55 of the Code of the
15	Federated S	States of Micronesia is hereby amended to read as follows:
16		"Section 202. [Declaration of policy] Disclosure of
17		accounting policy.
18		(1) [It is the declared policy of the Government of
19		the Federated States of Micronesia that:] The accounting
20		of the Federated States of Micronesia Government shall
21		provide full disclosure of the results of financial
22		operations, adequate financial information needed in the
23		management of operations, and the formulation and
24		execution of the national budget and shall ensure
25		effective control over income, expenditures, funds,

1	property, and other assets, whether tangible or
2	intangible.
3	(2) [The accounting of the Federated States of
4	Micronesia shall be performed in a manner consistent
5	with generally accepted accounting principles as
6	established by the United States Governmental Accounting
7	Standards Board] The accounting of the Federated States
8	of Micronesia shall be performed in a manner consistent
9	with generally accepted accounting principles.
10	(3) Full consideration shall be given to the needs and
11	responsibilities of both the legislative and executive
12	branches of the Government in the establishment of
13	accounting and reporting systems and such other fiscal
14	requirements.
15	(4) It is the responsibility of the executive branch
16	to maintain accounting systems and to produce financial
17	reports with respect to the operations of the executive
18	departments and staff offices, including central
19	facilities which gather and disseminate information on
20	the results of the financial operations of the Federated
21	States of Micronesia Government as a whole.
22	(5) Emphasis shall be placed on effectuating
23	systematic and orderly improvements in financial
24	management of the Federated States of Micronesia

Government in order to formulate, adopt, and maintain

1	simplified and more effective accounting systems,
2	financial reporting procedures, budget processes,
3	auditing requirements, and procedures, to safeguard
4	against duplication and to eliminate systems and
5	processes that do not serve a purpose commensurate with
6	the costs involved.
7	(6) The Secretary of Finance, together with the Budget
8	Officer, shall conduct a continuous review program for
9	the improvement of accounting and financial reporting in
10	the Government of the Federated States of Micronesia."
11	Section 18. Section 204 of title 55 of the Code of the
12	Federated States of Micronesia is hereby repealed in its entirety
13	and a new section 204 is hereby enacted to read as follows:
14	"Section 204. Secretary of Finance - general duties.
15	(1) The Secretary of Finance shall be the principal
16	financial adviser for the Government and shall, in
17	addition, prepare and review plans for the improvement
18	and management of revenue and for the support of the
19	public credit; shall supervise the collection of all
20	revenues; prescribe the forms of keeping and rendering
21	all public accounts and returns; grant, subject to
22	statutory provisions, all warrants for money to be
23	issued from the National Treasury in pursuance of
24	appropriations by law; prepare and issue reports and
25	fiscal information as may be required by law; and

1	generally perform all such services as he or she may be
2	directed to perform from time to time.
3	(2) Subject to the provisions of this act, or any
4	other enactment or any regulations, the Secretary may,
5	from time to time, issue instructions to ensure
6	compliance with the financial disciplines and rules
7	provided for in title 55.
8	(3) The Secretary may delegate the authority
9	for such functions to such extent as he or she may deem
10	practical and permissible by law."
11	Section 19. Title 55 of the Code of the Federated States of
12	Micronesia, as amended, is hereby further amended by enacting a new
13	section 205A to read as follows:
14	"Section 205A. Statements of account.
15	(1) The Secretary must as soon as practical after the
16	end of each fiscal year, but no later than the end of
17	the third month of the next succeeding fiscal year,
18	prepare and send to the Public Auditor a financial
19	statement of transactions affecting the funds
20	established under this act and encompassing the
21	information required under section 103G of this title.
22	(2) The financial statement of transactions, together
23	with the report thereon by the Public Auditor, must be
24	forwarded to the Speaker of the Congress within one
25	month of it being received by the Public Auditor, and

1	the Speaker shall circulate the statement to members and
2	offer the members the opportunity to debate the
3	statement in open session.
4	(3) When the Public Auditor has not completed his or
5	her report on the financial statement of transactions,
6	he or she must report on those which are accountable and

8	reported, state why, and when they can be expected."
9	Section 20. Title 55 of the Code of the Federated States of
10	Micronesia, as amended, is hereby further amended by enacting a new
11	section 205B to read as follows:
12	"Section 205B. Reporting, responsibilities of official
13	for reporting; other relevant matters under this act.
14	(1) The Secretaries of Finance and Administration and
15	Economic Affairs are jointly responsible for preparing
