## ELEVENTH CONGRESS OF THE FEDERATED STATES OF MICRONESIA

THIRD SPECIAL SESSION, 2000CONGRESSIONAL BILL NO. 11-197, C.D.1, C.D.2 Public Law No. 11-69\_

## AN ACT

To amend Public Law No. 11-59, by amending sections 1 and 3 to apportion funds, by amending section 4 to make a technical correction to a place name, and by amending section 7 to remove the requirement for a meeting between certain allottees and Congress Delegations, and for other purposes.

BE	E IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:					
1	Section 1. Section 1 of Public Law No. 11-59 is hereby

2	Section 4. Section 7 of Public Law No. 11-59 is hereby
3	amended to read as follows:
4	"Section 7. <u>Allotment and management of fund and lapse date</u> .
5	(1) All funds appropriated by this act shall be allotted,
6	managed, administered, and accounted for in accordance with
7	applicable law, including, but not limited to, the Financial
8	Management Act of 1979. The allottee of the funds
9	appropriated under subsections (1), (2), (4), (5) and (11) of
10	section 1 of this act shall be the Secretary of the
11	Department of Finance, or his designee. The allottee of the
12	funds appropriated under subsection (3) of section 1 and the
13	funds appropriated under section 6 of this act shall be the
14	Governor of the State of Kosrae, or his designee. The
15	allottees of the funds appropriated under subsections (6)
16	through (9) of section 1 of this act shall be the Mayors of
17	the respective towns or municipalities. The allottee of the
18	funds appropriated under subsection (10) of section 1 of this
19	act shall be the Speaker of the Congress of the Federated
20	States of Micronesia, or his designee. The allottee of the
21	funds appropriated under sections 2 and 5 of this act shall
22	be the President of the Federated States of Micronesia, or
23	his designee. The allottee of the funds appropriated under
24	section 3 of this act shall be the Chuuk State Commission on
25	Improvement Projects; EXCEPT THAT the allottee of the funds

1	appropriated under subsection (6)(d) of section 3 of this act
2	shall be the Northwest Project Coordinator. The allottee of
3	the funds appropriated under subsections (1) through (13) of
4	section 4 of this act shall be the Governor of the State of
5	Yap, or his designee. The allottee of the funds appropriated
6	under subsection (14) of section 4 of this act shall be the
7	Speaker of the Congress of the Federated States of
8	Micronesia, or his designee. The allottees shall be
9	responsible for ensuring that the funds appropriated by this
10	act, or so much thereof as may be necessary, are used solely
11	for the purpose specified in this act, and that no
12	obligations are incurred in excess of the sum appropriated.
13	(2) The authority of the allottees to obligate funds
14	appropriated by this act shall lapse as of September 30,
15	2002."
16	Section 5. This act shall become law upon approval by the
17	President of the Federated States of Micronesia or upon its becoming
18	law without such approval.
