Public Law No. 11-80

AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia, as amended, by amending section 204 to require the Secretary of the Department of Finance and Administration to ensure that all allottees comply with reporting requirements; to amend section 226 to require the Secretary of Finance and Administration to provide financial reports to Congress; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 204 of title 55 of the Code of the Federated
- 2 States of Micronesia is hereby amended to read as follows:
- 3 "Section 204. <u>Secretary of the Department of Finance and</u>
- 4 <u>Administration General duties</u>.
- 5 (1) The Secretary of the Department of Finance and 6 Administration shall prepare and review plans for the 7 improvement and management of revenue and for the support of the public credit; supervise the collection of all revenues; 8 9 prescribe the forms of keeping and rendering all public 10 accounts and returns; grant, subject to statutory provisions, all warrants for moneys to be issued from the National 11 12 Treasury in pursuance of appropriations by law; prepare and 13 issue reports and fiscal information as may be required by law; and generally perform all such services relative to 14 finances as he shall be directed to perform from time to 15 16 time.
 - (2) The Secretary of the Department of Finance and Administration shall ensure that all allottees comply with reporting requirements of section 226 of this title.
- 20 (3) The Secretary of the Department of Finance and
 21 Administration may delegate the authority for such functions
 22 to such extent as he may deem practicable and

is permissible by law."

2 Section 2. Section 226 of title 55 of the Code of the Federated 3 States of Micronesia is hereby amended to read as follows:

"Section 226. Required Reports.

(1) Required Reports from Allottees.

- (a) Not later than May 1 of each year, each allottee shall submit a report to the Congress of the Federated States of Micronesia which shall provide for the full accounting of each line item, or subsection apportioning funds, as of the end of the second quarter of the fiscal year, detailing obligations incurred against all sums appropriated by the Congress of the Federated States of Micronesia or made available to an allottee from other sources, to include a detailed explanation and full justification for each major deviation from a line item, or subsection apportioning funds.
- (b) Not later than October 31 of each year, each allottee shall submit a report to the Congress of the Federated States of Micronesia which shall provide for the full accounting of each line item, or subsection apportioning funds as of the end of the fiscal year, detailing obligations and expenditures incurred against all sums appropriated by the Congress of the Federated States of Micronesia or made available to an allottee from other sources, to include a detailed explanation and full justification for each major deviation from a line item, or subsection apportioning funds.

(c) The reports required by subparagraphs (a) and (b)
above shall include a statement by the allottee of the status
of the project, program, or list the achievements of the
department or agency for which the funds were allotted. For
all allottees, except those receiving allotments for
Governmental Operations, the statement shall detail the
percentage of completion of the project or program and shall
include an estimation of the completion date for the project
or program, where appropriate.

- (2) Required Reports from the Secretary of the Department of Finance and Administration.
- (a) Not later than January 31 of each year, the Secretary of the Department of Finance and Administration shall submit unaudited financial statements of the National Government to the Congress of the Federated States of Micronesia, or, he shall provide in writing, an explanation of why he is unable to provide such reports. The explanation shall include a date by which he will provide the required reports.
- (b) Ten days prior to each session of Congress, whether a regular or special session, the Secretary of the Department of Finance and Administration shall submit, to the Speaker of [q] the Congress and to the Chairman of the Committee on Ways and Means, an accurate report of current projected revenues for the fiscal year. This report shall

1	detail projected revenues by source and shall reflect
2	appropriations made during the fiscal year. The report
3	should show the balance of funds available for appropriation
4	by the Congress."
5	Section 3. This act shall become law upon approval by the
6	President of the Federated States of Micronesia or upon its becoming
7	law without such approval.
