A BILL FOR AN ACT

To further amend Public Law No. 11-54, as amended by Public Laws Nos. 11-56, 11-63, 11-67, 11-73 and 12-1, by further amending section 19, as amended by Public Laws Nos. 11-56, 11-67, 11-73 and 12-1, to change the allottee of the Pre-Convention and Constitutional Convention funds and to extend the lapse date for these funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 19 of Public Law No. 11-54, as amended by
- 2 Public Laws Nos. 11-56, 11-67, 11-73 and 12-1, is hereby further
- 3 amended to read as follows:
- 4 "Section 19. Allotment and management of funds and
- 5 lapse date.
- 6 (1) General Provisions.
- 7 (a) All funds appropriated by this act shall be
 8 allotted, managed, administered, and accounted for in
 9 accordance with applicable law, including, but not
 10 limited to, the Financial Management Act of 1979.
- 11 (b) The allottees shall be responsible for
 12 ensuring that these funds, or so much thereof as may be
 13 necessary, are used solely for the purpose specified in
 14 this act, and that no obligations are incurred in excess
 15 of the sum appropriated.
- (c) No purchase order or contract for the

 purchase of a fixed asset with a value of \$1,000 or more

 shall be approved until the property inventory records

of the requesting entity are updated, current, and on
file with the Department of Finance and Administration,
in accordance with law.

- (d) No purchase order or contract for the purchase of photocopying equipment, computers, or vehicles shall be approved until the requesting department or branch of government has on file, with the Department of Finance and Administration, a plan for the centralized maintenance of such equipment, computers and vehicles.
- (2) Specific provisions. Within section 15, the funds appropriated to Pohnpei State under subsection (2) of this act and the funds appropriated to Chuuk State under subsection (3) of this act shall be retained in the General Fund of the Federated States of Micronesia until a scholarship recipient is identified to the President or the President's designee, at which time scholarship funds in the amount of the scholarship award shall be disbursed directly to the educational institution in the form of a two-party check payable to both the scholarship recipient and the educational institution he or she is attending.
- (3) Allottees. The allottees of the funds appropriated by this act are as follows:
 - (a) section 2 the allottee of these funds shall

1	be the President of the Federated States of Micronesia;
2	(b) section 3 - the allottee of these funds shall
3	be the Speaker of the Congress of the Federated States
4	of Micronesia;
5	(c) section 4 - the allottee of these funds shall
6	be the Chief Justice of the Supreme Court of the
7	Federated States of Micronesia;
8	(d) section 5 - the allottee of these funds shall
9	be the Public Auditor;
10	(e) sections 6 through 16 - the allottee of these
11	funds shall be the President of the Federated States of
12	Micronesia or his designee; EXCEPT THAT for the
13	following subsections of sections 6 through 16 of this
14	act, the allottees shall be:
15	(i) section 8, subsection (4) - the allottee
16	of these funds shall be the Governor of the respective
17	State, or his designee;
18	(ii) [section 8, subsection (5)(f) - the
19	allottee of these funds shall be the Secretary of the
20	Department of Transportation, Communication and
21	Infrastructure;
22	(iii) section 8, subsection (7)(a), (b), (c)
23	and (d) - the allottee of these funds shall be the Chief
24	Justice of the respective State;
25	(iii) section 8, subsections (7)(h) and (i) -

1 the allottee of these funds shall be the President of 2 the Pre-Convention Committee, or his designee, until such time as the President of the Convention is elected. 3 4 Once elected, the President of the Convention, or his 5 designee, shall become the allottee of these funds. (iv) section 13, subsection (2) - the 6 7 allottee of these funds shall be the President of the College of Micronesia-FSM; 8 (v) section 15, subsections (1), (2), (3) 9 10 and (4) - the allottee of these funds shall be the 11 Governor of the respective State. (vi) section 16, subsection (8)(a) - the 12 allottee of these funds shall be the Governor of Yap 13 14 State. 15 (vii) section 16, subsection (8)(b) - the allottee of these funds shall be the Chuuk State 16 17 Commission on Improvement Projects. 18 (4) Lapse date. The authority of the allottees to obligate funds appropriated by this act shall lapse as 19 of September 30, 2001; EXCEPT THAT the authority of the 20 21 allottee to obligate funds appropriated under 22 subsections (7)(h) and (i) $[\frac{(5)(f)}{(f)}]$ of section 8 for [Yap Outer Islands] the Pre-Constitutional Convention 23 and the Constitutional Convention shall lapse as of 24 25 September 30, 2002, and the authority of the allottee to

obligate funds appropriated by section 15(4) for post secondary assistance for the State of Yap shall not lapse." Section 2.
