A BILL FOR AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia, as amended, by repealing sections 102, 103, 106, 204, 215, 225 and 226 in their entirety; by enacting new sections 102, 103, 103A to 103G, 106, 106A to 106D, 201A, 204, 205A to 205G, 223, 223A to 223D and 226; by amending section 202; and by renumbering sections 216 to 223 as sections 215 to 222; for the purpose of enhancing effective and responsible management by government; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. <u>Purpose</u>. The purposes of the amendments contained
- 2 herein are to foster and enhance effective and responsible economic and
- 3 fiscal management by government, including adherence to policy; and to
- 4 provide enhanced accountability arrangements; thereby requiring the
- 5 Executive to produce:
- 6 (1) statements of proposed policy;
- 7 (2) confirmation of adherence to fiscal disciplines;
- 8 (3) economic and fiscal statements, including economic and
- 9 fiscal forecasts and updates; and
- 10 (4) financial management information, including comprehensive
- 11 annual reports.
- 12 Section 2. Section 102 of title 55 of the Code of the Federated
- 13 States of Micronesia is hereby repealed in its entirety and a new
- 14 section 102 is hereby enacted to read as follows:
- "Section 102. <u>Definitions</u>. In this title, unless otherwise
- 16 <u>expressly provided and unless the context otherwise requires:</u>
- 17 (1) 'Agency' or 'Agencies' means any agency, commission,

1	authority, board, bureau, or other organization of the
2	National Government established by law and not specifically
3	part of one of the three branches of the National Government.
4	(2) 'Allotment' means the delegation of authority to a
5	person to create legally enforceable financial obligations in
6	accordance with applicable law on behalf of the Federated
7	States of Micronesia, within specified limits set forth in an
8	appropriation act of the Federated States of Micronesia or as
9	may be required by the terms of funding available from other
10	sources.
11	(3) 'Allot' means to make an allotment.
12	(4) 'Allottee' means any person or entity to whom an
13	allotment is made.
14	(5) 'Annual budget proposal' means the annual request for
15	new obligation and expenditure authority during the ensuing
16	fiscal year by all branches and agencies of the National
17	Government for all purposes, including but not limited to,
18	Government operations, development programs and projects,
19	special programs, contributions, grants and subsidies.
20	(6) 'Appropriation' or 'appropriation act' means a law
21	enacted by Congress which authorizes the National Government
22	to incur obligations and make payments out of the National
23	Treasury in accordance with law.
24	(7) 'Borrowing' means money loaned to the National
25	Government and not required to be repaid in full within the

1	current fiscal year and 'borrowing expenses' are expenses
2	related to such a borrowing.
3	(8) 'Congress' means the Congress of the Federated States
4	of Micronesia.
5	(9) 'Department' means a department or office of the FSM.
6	(10) 'Fiscal year' means the twelve month period from
7	October 1 of one calendar year through September 30 of the
8	succeeding calendar year.
9	(11) 'FSM' means the Federated States of Micronesia.
LO	(12) 'Head of department' or 'department head' means a
11	secretary or head of a department or agency, however called.
L2	(13) 'National Government' means the department and offices
13	of the executive branch, Congress, the judicial branch and
L4	agencies of the National Government.
L5	(14) 'Output' and 'outcome' means the production of goods
L6	and services by a department, Congress, the judicial branch,
L7	an agency of the National Government or an allottee.
L8	(15) 'Person' means any natural person, company,
L9	corporation, partnership, trust, incorporated or
20	unincorporated society, charitable body, or other
21	organization or entity recognized by law.
22	(16) 'Public funds' means all the funds, resources and
23	entitlements owned by, owed to, or held by the National
24	Government, or held by any person for or on behalf of the
25	National Government, and includes public resources.

1	(17) 'Public resources' means real or personal property that
2	is the property of the National Government, and includes
3	public funds.
4	(18) 'Secretary' or 'Secretary of Finance' means the
5	Secretary of Finance and Administration or his successor."
6	Section 3. Section 103 of title 55 of the Code of the Federated
7	States of Micronesia is hereby repealed in its entirety and a new
8	section 103 is hereby enacted to read as follows.
9	"Section 103. Annual budget.
10	(1) No later than June 30 of each year, the President shall
11	submit to the Congress the annual budget proposal for the
12	National Government for the ensuing fiscal year. The annual
13	budget proposal shall contain a statement of anticipated
14	revenues from all sources, details of operations and
15	development expenditures, and planned expenditures for all
16	sources of funds.
17	(2) The annual budget proposal shall be in a form that will
18	provide for a separate appropriation for each department,
19	Congress, the judicial branch, and agencies of the National
20	Government for each of the following categories:
21	(a) each category of output;
22	(b) each category of benefits, grants or subsidies;
23	(c) each category of borrowing expenses or repayment
24	of debts;
25	(d) each category of other non-operating expenses; and

1	(e) each category of capital acquisitions or capital
2	contributions.
3	(3) The authority to expend cash or incur expenses or
4	obligations under an appropriation act will lapse at the end
5	of the fiscal year to which that act relates but any
6	unexpended balance of any appropriation may be dealt with in
7	accordance with this act.
8	(4) The President shall submit the following with the
9	annual budget proposal:
10	(a) a budget message, which shall include such
11	supporting financial, statistical, output performance, and
12	other information, data and recommendations as the President
13	may determine are in the public interest and consistent with
14	the principles of fiscal responsibility set out in section
15	201A of this title;
16	(b) proposed legislation to appropriate funds for the
17	National Government for the ensuing fiscal year, reflecting
18	the President's recommendations as contained in the proposed
19	budget and in accordance with the requirements specified
20	under section 106A of this title;
21	(c) a statement, including forecasts, providing a
22	projection of expenditures for each category of outputs for
23	the ensuing fiscal year and the two years following that
24	fiscal year including:
25	(i) the details of the estimated revenue of the

1	National Government;
2	(ii) the details of the estimated expenditures for
3	each department or agency;
4	(iii) the National Government's debt management
5	responsibilities and, where necessary, the details of a
6	financial plan to meet those responsibilities; and
7	(iv) that the annual budget proposal is fiscally
8	responsible in accordance with the principles set forth in
9	section 201A of this title, particularly, and in title 55,
10	generally."
11	Section 4. Title 55 of the Code of the Federated States of
12	Micronesia, as amended, is hereby further amended by enacting a new
13	section 103A to read as follows:
14	"Section 103A. Fiscal strategy report.
15	(1) The President shall submit to Congress, at the same
16	time as, and in addition to the annual budget proposal, a
17	report on the Executive's fiscal strategy.
18	(2) The fiscal strategy report shall:
19	(a) include an assessment of the extent to which the
20	annual budget proposal is consistent with the economic and
21	fiscal policy statement required under section 103B of this
22	<u>title;</u>
23	(b) include an explanation of the reasons for any
24	significant differences between the current economic and
25	financial situation of the National Government and the

1	information and intentions presented in the previous economic
2	and fiscal policy statement required under section 103B of
3	this title;
4	(c) where the circumstances have changed, present an
5	amended set of intentions;
6	(d) provide projections of movements in the variables
7	specified in sections 103F and 103G of this title which
8	demonstrate intended progress towards achieving the longer
9	term objectives specified in the economic and fiscal policy
10	statement most recently published and state the significant
11	assumptions on which the projections are based."
12	Section 5. Title 55 of the Code of the Federated States of
13	Micronesia, as amended, is hereby further amended by enacting a new
14	section 103B to read as follows:
15	"Section 103B. Economic and fiscal policy statement.
16	(1) The President shall submit to Congress and publish, not
17	later than March 31 of each year, an economic and fiscal
18	policy statement for the fiscal year commencing on October 1
19	after publication, and forecasts for the two years following
20	that fiscal year, and this economic and fiscal policy
21	statement shall:
22	(a) specify the economic and fiscal policy that the
23	executive branch and agencies will follow in all economic and
24	fiscal dealings, and disciplines that each will adhere to;
25	(b) specify or re-affirm the President's long-term

1	fiscal policy objectives and in particular, provide for the
2	principle variables specified in sections 103F and 103G of
3	this title;
4	(c) specify the broad strategic priorities by which
5	the executive branch and agencies will be guided in preparing
6	the budget for that fiscal year;
7	(d) indicate by use of ranges, ratios, or other means,
8	the President's intentions regarding the variables specified
9	in sections 103F and 103G of this title; and
10	(e) indicate other expenditures that the President
11	anticipates will be in the budget.
12	(2) The economic and fiscal policy statement shall also:
13	(a) assess the extent to which the objectives,
14	priorities, and intentions referred to under subsection (1)
15	of this section are consistent with the requirement to
16	produce a balanced budget under section 104 of this title;
17	<u>and</u>
18	(b) assess the consistency of the objectives,
19	priorities, and intentions referred to under subsection (1)
20	of this section with the objectives, priorities, and
21	intentions indicated in the immediately preceding economic
22	and fiscal policy statement; or, if amended, the amended
23	statement and, where these are not consistent, justify the
24	<u>departure.</u>
25	(3) Any member of the public may, within twenty-eight days

1	of the economic and fiscal policy statement being published,
2	deliver in writing to the office of the President any
3	submission that person may have in respect of that statement
4	The President shall consider any submission made in
5	accordance with this section."
6	Section 6. Title 55 of the Code of the Federated States of
7	Micronesia, as amended, is hereby further amended by enacting a new
8	section 103C to read as follows:
9	"Section 103C. Economic and fiscal update.
10	(1) The President shall, no later than October 1 in each
11	fiscal year, publish a report updating the economic and
12	fiscal policy statement for the fiscal year beginning from
13	that day.
14	(2) The economic and fiscal update report shall contain:
15	(a) an economic and fiscal update for the current
16	fiscal year, and forecasts for the following two fiscal
17	years, containing the information specified in sections 103F
18	and 103G of this title; and
19	(b) a statement of the date on which the contents of
20	the report were finalized."
21	Section 7. Title 55 of the Code of the Federated States of
22	Micronesia, as amended, is hereby further amended by enacting a new
23	section 103D to read as follows:
24	"Section 103D. <u>Information to be supplied by Congress, the</u>
25	judicial branch, and agencies.

1	The Congress, the judicial branch, and agencies shall
2	transmit to the President, no later than June 1 of each year,
3	details of planned operational and development expenditures
4	and projected revenue. The Congress, the judicial branch,
5	and agencies shall also transmit budget projections for each
6	of the two subsequent fiscal years and such other information
7	as may be required by law. The President shall include such
8	planned expenditures, projected revenue, and budget
9	projections in the annual budget proposal without revision,
10	and subject to his or her recommendations."
11	Section 8. Title 55 of the Code of the Federated States of
12	Micronesia, as amended, is hereby further amended by enacting a new
13	section 103E to read as follows:
14	"Section 103E. Information to be supplied by governments,
15	entities and others.
16	Each State Government, municipality, or other government
17	organization or official who seeks National Government funds
18	for development programs or projects shall transmit to the
19	President, no later than June 1 of each year, planned
20	developmental expenditures for the ensuing fiscal year.
21	State Governments shall also transmit a statement of the
22	State's general economic and fiscal plan, including a
23	priority schedule of the development projects the State plans
24	to undertake and the reasons therefor, developmental budget
25	projections for each of the two subsequent fiscal years, and

1	such other information as may be required by law. The
2	President shall include such planned expenditures, economic
3	and fiscal plans, and budget projections in the annual budget
4	proposal, without revision, but subject to his or her
5	recommendations."
6	Section 9. Title 55 of the Code of the Federated States of
7	Micronesia, as amended, is hereby further amended by enacting a new
8	section 103F to read as follows:
9	"Section 103F. Economic and fiscal data.
LO	(1) Economic reports required under chapters 1 and 2 of
L1	title 55 shall include forecasts depicting movements in the
L2	Federated States of Micronesia of:
L3	(a) gross domestic product, including the major
L4	components of gross domestic product;
L5	(b) consumer prices;
L6	(c) employment levels;
L7	(d) balance of payments; and
L8	(e) such other information deemed necessary by the
L9	President (after consultation with the Secretaries of
20	Economic Affairs and the Department of Finance and
21	Administration) to provide a comprehensive economic forecast.
22	(2) Fiscal forecasts required under chapters 1 and 2 of
23	title 55 shall include:
24	(a) forecast information with respect to the
25	statements required under section 103G of this title;

1	(b) forecast information with respect to the current
2	fiscal year update and comparative budgeted and actual
3	figures for the fiscal year immediately preceding the first
4	of the fiscal years to which the fiscal forecast relates; and
5	(c) details of fiscal risks and, where they cannot be
6	quantified, a description of possible impacts.
7	(3) Economic forecasts shall include a statement of all
8	significant assumptions underlying them."
9	Section 10. Title 55 of the Code of the Federated States of
LO	Micronesia, as amended, is hereby further amended by enacting a new
L1	section 103G to read as follows:
L2	"Section 103G. Reporting requirements.
L3	(1) Any forecast or statement required under chapters 1 and
L4	2 of title 55 shall include details of:
L5	(a) the total operating expenditures;
L6	(b) the total benefits, grants or
L7	subsidies;
L8	(c) all other expenditures;
L9	(d) the total operating revenues;
20	(e) all other revenue;
21	(f) the difference between all expenditure and all
22	revenue;
23	(g) the level of total debt; and
24	(h) the level of asset holdings.
25	(2) Each report shall also include:

1	(a) a statement of financial position;
2	(b) a statement of financial performance;
3	(c) a statement of cash flows;
4	(d) a statement of borrowings;
5	(e) a statement of obligated but unexpended funds
6	(excluding borrowings);
7	(f) such other statements as are required to be
8	consistent with generally accepted accounting principles and
9	practice; and
LO	(g) a statement of accounting policies."
L1	Section 11. Section 106 of title 55 of the Code of the Federated
L2	States of Micronesia is hereby repealed in its entirety and a new
L3	section 106 is hereby enacted to read as follows:
L4	"Section 106. Appropriations by Congress.
L5	(1) The Congress, after receipt of the proposed budget from
L6	the President shall, no later than August 29 of each year, by
L7	act, adopt the annual budget of the National Government for
L8	the ensuing fiscal year.
L9	(2) Congress may alter the budget submitted by the
20	President, in any respect.
21	(3) Prior to altering the annual budget proposal submitted
22	by the President, Congress shall first advise the President
23	what specific part or parts it intends to alter, and the
24	reasons therefor, and give the President (or his designee)
25	the opportunity, within no less than seven days, to address

1	Congress on the alterations proposed.
2	(4) The budget alteration authority of Congress shall be
3	executed by means of appropriation legislation.
4	Appropriations or authorizations for the expenditure of funds
5	shall be made by law, except as provided in section 108 of
6	this title.
7	(5) Congress may restrict, by law, the expenditure of funds
8	for a specific purpose.
9	(6) Notwithstanding section 217 of this title and unless
10	otherwise specified by law:
11	(a) appropriations of National Government funds for
12	National Government development projects shall be allotted
13	through the President or the Governor of the State where the
14	project is being undertaken;
15	(b) appropriations of National Government funds for
16	non-National Government development projects shall be
17	allotted through the Governor of the State where the project
18	is being undertaken; and
19	(c) The President, or the Governor, as the case may
20	be, may only obligate funds where he or she is satisfied that
21	the project is in accordance with the appropriation, is
22	planned with realistic estimates of proposed expenditures,
23	and shall release funds where appropriate, by progress
24	payments, upon obtaining satisfactory evidence of the
25	obligation to incur such expenditure.

1	(7) If Congress does not appropriate National Government
2	funds through the President or Governor in accordance with
3	subsection (6) of this section, it shall record in the
4	Congress journal or in a committee report the reasons for the
5	departure and, shall record the details of the project, the
6	project plan, and the result intended to be achieved, and
7	ensure that the appropriation act reflects those details."
8	Section 12. Title 55 of the Code of the Federated States of
9	Micronesia, as amended, is hereby further amended by enacting a new
LO	section 106A to read as follows:
L1	"Section 106A. Appropriations format.
L2	(1) No expense or liability will be incurred by the
L3	National Government unless the expenditure, in relation to
L4	such expense or obligation, is capable of being charged to a
L5	category specified in subsection (2) of this section.
L6	(2) Within an appropriation act, separate appropriation
L7	lines shall be made for each of the following categories:
L8	(a) each category of output;
L9	(b) each category of benefits, grants, or subsidies;
20	(c) each category of borrowing expenses or repayment
21	of debts;
22	(d) each category of other non-operating expenses; and
23	(e) each category of capital acquisitions or capital
24	contributions."
25	Section 13. Title 55 of the Code of the Federated States of

1	Micronesia, as amended, is hereby further amended by enacting a new
2	section 106B to read as follows:
3	"Section 106B. Reprogramming.
4	(1) A department head may, from time to time, make
5	transfers between outputs where:
6	(a) the transfer does not conflict with performance of
7	the outputs specified in the budget policy;
8	(b) the total appropriation for that fiscal year for
9	that department is unaltered.
10	(2) The department head must advise the Secretary who shall
11	ensure that sufficient details to explain any transfer made
12	pursuant to subsection (1) of this section will be included
13	in a report to the President.
14	(3) The President may reprogram up to ten percent to and
15	from the funds appropriated to each department and office in
16	the annual budget act, after first specifying the outputs for
17	which funding is either increased or decreased."
18	Section 14. Title 55 of the Code of the Federated States of
19	Micronesia, as amended, is hereby further amended by enacting a new
20	section 106C to read as follows:
21	"Section 106C. Net appropriations.
22	(1) An appropriation may be shown in the appropriation act
23	to be off-set by an amount of revenue where that revenue
24	applies to the recovery costs of the relevant budget output
25	and meets the criteria set for that output by the Secretary.

1	(2) Where an appropriation is for a net appropriation, all
2	estimated expenditures and revenue, from all sources, must be
3	included in the budget statement and provided for in the
4	annual budget proposal to reflect how the net appropriation
5	figure was ascertained."
6	Section 15. Title 55 of the Code of the Federated States of
7	Micronesia, as amended, is hereby further amended by enacting a new
8	section 106D to read as follows:
9	"Section 106D. Transfer and subsequent expenditure of
10	unexpended appropriations.
11	Where provision has been made in any appropriation act for
12	expenditure, but that expenditure was not incurred during
13	the fiscal year to which the act relates, the President may,
14	after consultation with the Cabinet, direct that the
15	unexpended amount, or a portion thereof, be reappropriated
16	for the next fiscal year to the department or government
17	agency that did not expend the amount appropriated to it for
18	expenditure in accordance with the outputs specified in the
19	original appropriation."
20	Section 16. Title 55 of the Code of the Federated States of
21	Micronesia, as amended, is hereby further amended by enacting a new
22	section 201A to read as follows:
23	"Section 201A. Fiscal responsibility.
24	(1) The National Government shall pursue its policy
25	objectives in accordance with the principles of responsible

1	fiscal management specified in subsection (2) of this
2	section.
3	(2) The principles of responsible fiscal management are:
4	(a) managing and keeping the total debt at such levels
5	that a balanced budget is achieved;
6	(b) achieving and maintaining levels of FSM net worth
7	that provide a buffer against factors that may adversely
8	impact the FSM's net worth in the future;
9	(c) prudently managing the fiscal risks facing the
10	FSM; and
11	(d) pursuing policies that are consistent with a
12	reasonable degree of predictability about the level and
13	stability of tax rates for future years."
14	Section 17. Section 202 of title 55 of the Code of the Federated
15	States of Micronesia is hereby amended to read as follows:
16	"Section 202. [Declaration of policy] Disclosure of
17	accounting policy.
18	[It is the declared policy of the Government of the Federated
19	States of Micronesia that:
20	(1) The accounting of the Federated States of Micronesia
21	Government shall provide full disclosure of the results of
22	financial operations, adequate financial information needed
23	in the management of operations, and the formulation and
24	execution of the national budget and shall ensure effective
25	control over income, expenditures, funds, property, and other

1 assets, whether tangible or intangible.

- (2) The accounting of the Federated States of Micronesia shall be performed in a manner consistent with generally accepted accounting principles [as established by the United States Governmental Accounting Standards Board].
- (3) Full consideration <u>shall</u> be given to the needs and responsibilities of both the legislative and executive branches of the Government in the establishment of accounting and reporting systems and such other fiscal requirements.
- (4) It is the responsibility of the executive branch to maintain accounting systems and to produce financial reports with respect to the operations of the executive departments and staff offices, including central facilities which gather and disseminate information on the results of the financial operations of the Federated States of Micronesia Government as a whole.
- (5) Emphasis shall be placed on effectuating systematic and orderly improvements in financial management of the Federated States of Micronesia Government in order to formulate, adopt, and maintain simplified and more effective accounting systems, financial reporting procedures, budget processes, auditing requirements, and procedures, [and] to safeguard against duplication and to eliminate systems and processes that do not serve a purpose commensurate with the costs involved.

1	(6) The Secretary of Finance, together with the Budget
2	Officer, shall conduct a continuous review program for the
3	improvement of accounting and financial reporting in the
4	Government of the Federated States of Micronesia."
5	Section 18. Section 204 of title 55 of the Code of the Federated
6	States of Micronesia is hereby repealed in its entirety and a new
7	section 204 is hereby enacted to read as follows:
8	"Section 204. Secretary of Finance - general duties.
9	(1) The Secretary of Finance shall be the principal
10	financial adviser for the Government and shall, in addition,
11	prepare and review plans for the improvement and management
12	of revenue and for the support of the public credit; shall
13	supervise the collection of all revenues; prescribe the forms
14	of keeping and rendering all public accounts and returns;
15	grant, subject to statutory provisions, all warrants for
16	money to be issued from the National Treasury in pursuance of
17	appropriations by law; prepare and issue reports and fiscal
18	information as may be required by law; and generally perform
19	all such services as he or she may be directed to perform
20	from time to time.
21	(2) Subject to the provisions of this act, or any other
22	enactment or any regulations, the Secretary may, from time to
23	time, issue instructions to ensure compliance with the
24	financial disciplines and rules provided for in title 55.

(3) The Secretary may delegate the authority for such

1	functions to such extent as he or she may deem practical and
2	permissible by law."
3	Section 19. Title 55 of the Code of the Federated States of
4	Micronesia, as amended, is hereby further amended by enacting a new
5	section 205A to read as follows:
6	"Section 205A. Statements of account.
7	(1) The Secretary must as soon as practical after the end
8	of each fiscal year, but no later than the end of the third
9	month of the next succeeding fiscal year, prepare and send to
10	the Public Auditor a financial statement of transactions
11	affecting the funds established under this act and
12	encompassing the information required under section 103G of
13	this title.
14	(2) The financial statement of transactions, together with
15	the report thereon by the Public Auditor, must be forwarded
16	to the Speaker of the Congress within one month of it being
17	received by the Public Auditor, and the Speaker shall
18	circulate the statement to members and offer the members the
19	opportunity to debate the statement in open session.
20	(3) When the Public Auditor has not completed his or her
21	report on the financial statement of transactions, he or she
22	must report on those which are accountable and list those
23	which are accountable that cannot yet be reported, state why,
24	and when they can be expected."

Section 20. Title 55 of the Code of the Federated States of

Micronesia, as amended, is hereby further amended by enacting a new section 205B to read as follows: "Section 205B. Reporting, responsibilities of officials for 3 4 reporting; other relevant matters under this act. (1) The Secretaries of the Department of Finance and 5 Administration and Economic Affairs are jointly responsible 6 7 for preparing and delivering to the President the financial information required under chapters 1 and 2 of title 55. 8 (2) Every department head shall, at intervals fixed by the 9 Secretary, but in any event at the end of each quarter in 10 each fiscal year, report in accordance with the instructions 11 of the Secretary, on the variables specified in section 103G 12 13 of this title as they relate to the applicable department or 14 agency. (3) At the conclusion of each fiscal year, all heads of 15 departments and agencies shall present to the Secretary an 16 17 annual report as specified by the Secretary and covering all the information required under section 103G of this title as 18 19 it applies to the department or agency.

- (4) Such annual report shall specify the results achieved in comparison with the budget message and the provision of outcomes in the annual budget proposal for which all appropriation was provided under the appropriation act.
- (5) The financial statements of each department or agency shall at the end of the fiscal year, be examined and reported

1	upon by the Public Auditor and transmitted to the Speaker of
2	Congress as soon as practical after forwarding the financial
3	statement of transactions required under section 205A(2) of
4	this title."
5	Section 21. Title 55 of the Code of the Federated States of
6	Micronesia, as amended, is hereby further amended by enacting a new
