## A BILL FOR AN ACT

To further amend Public Law No. 12-12, as amended, by amending section 13 to reallocate unused funds previously appropriated for MS Caroline Islands drydocking for use in airport projects in Chuuk State Election Districts Nos. 1 and 3 and by amending section 16 to change, the allottee and lapse date, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 13 of Public Law No. 12-12, as amended by
- 2 Public Laws Nos. 12-21[<del>and 12-24</del>], 12-24 and 12-35, is hereby
- 3 further amended to read as follows:
- "Section 13. <u>Capital and Human Resource Development</u>.

  The sum of \$11,415,200, or so much thereof as may be
- 6 necessary, is hereby appropriated from the General Fund
- of the Federated States of Micronesia for the fiscal
- 8 year ending September 30, 2002, for capital improvement,
- 9 development programs and projects and human resource
- 10 development. Of the total funds appropriated under this
- section, \$2,955,926 shall be deemed to come from the
- 12 capital account funds available under section 211 of the
- Compact of Free Association, and \$1,387,700 from the
- funds available under section 216(a)(3) of the Compact
- of Free Association. The sum appropriated under this
- 16 section shall be apportioned as follows:
- 17 (1) College of Micronesia-FSM
- 18 (a) Operations of the College of

3	Section 2. Section 16 of Public Law No. 12-12, as amended by
4	Public Laws Nos. 12-21 and 12-24, is hereby further amended to
5	read as follows:
6	"Section 16. Allotment and management of funds and
7	lapse date.
8	(1) General Provisions.
9	(a) All funds appropriated by this act shall be
10	allotted, managed, administered, and accounted for in
11	accordance with applicable law, including, but not
12	limited to, the Financial Management Act of 1979;
13	(b) The allottees shall be responsible for
14	ensuring that these funds, or so much thereof as may be
15	necessary, are used solely for the purpose specified in
16	this act, and that no obligations are incurred in excess
17	of the sum appropriated.
18	(2) Allottees. The allottees of the funds
19	appropriated by this act are as follows:
20	(a) section 2 - the allottee of these funds shall
21	be the President of the Federated States of Micronesia;
22	(b) section 3 - the allottee of these funds shall
23	be the Speaker of the Congress of the Federated States
24	of Micronesia;
25	(c) section 4 - the allottee of these funds shall

1	be the Chief Justice of the Supreme Court of the
2	Federated States of Micronesia;
3	(d) section 5 - the allottee of these funds shall
4	be the Public Auditor;
5	(e) section 6 through 13 - the allottee of these
6	funds shall be the President of the Federated States of
7	Micronesia or his designee; EXCEPT THAT for the
8	following subsections of section 6 through 13 of this
9	act, the allottees shall be:
10	(i) section 8, subsection (5) - the allottee
11	of these funds shall be the Governor of the respective
12	State, or his designee;
13	(ii) section 8, subsection (6)(a) through
14	(6)(d) - the allottee of these funds shall be the
15	Secretary of the Department of Transportation,
16	Communication and Infrastructure;
17	(iii) section 8, subsection (8)(a) through
18	(8)(d) - the allottee of these funds shall be the Chief
19	Justice of the respective State;
20	(iv) section 8, subsection (8)(g) - the
21	allottee of these funds shall be the President of the
22	Federated States of Micronesia, or his designee, until
23	such time as the Constitutional Convention convenes and
24	selects a President and then the allottee of these funds
25	shall be the President of the Constitutional Convention.

1	(v) section 10, subsection (2)(b) - the
2	allottee of these funds shall be the Speaker of the
3	Congress of the Federated States of Micronesia, or his
4	designee;
5	(vi) section 10, subsection (2)(c) - the
6	allottee of these funds shall be the Chief Justice of
7	the Supreme Court of the Federated States of Micronesia;
8	(vii) section 13, subsection (1)(a) through
9	(1)( $[\pm]\underline{d}$ ) - the allottee of these funds shall be the
10	President of the College of Micronesia-FSM, EXCEPT THAT
11	the allottee of the funds appropriated under subsection
12	(1)(e) of section 13 shall be the Executive Director of
13	the Chuuk State Commission on Improvement Projects;
14	(viii) section 13, subsections (2)(a) through
15	(2)(d) - the allottee of these funds shall be the
16	Governor of the respective State.
17	(ix) section 13, subsections (1)(e)(i) and
18	(1) (e) (v) - the allottee of these funds shall be the
19	President of the FSM.
20	(3) Lapse date. The authority of the allottees to
21	obligate funds appropriated by this act shall lapse as
22	of September 30, 2002, EXCEPT THAT the authority of the
23	allottees to obligate funds appropriated by section 13,
24	subsections (1) and (2) [for post-secondary educational
25	assistance] shall not lapse."
