A BILL FOR AN ACT

To further amend Public Law 8-100, as amended, by amending section 6 to change the allottee of funds appropriated under subsections (6), (7), (8) and (9) of section 1, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 6 of Public Law No. 8-100, as amended by
- 2 Public Laws Nos. 8-121, 9-028, 12-27 and 12-44, is hereby further
- 3 amended to read as follows:
- 4 "Section 6. Allotment and management of funds and lapse
- 5 date.
- 6 (1) All funds appropriated by this act shall be
- 7 allotted, managed, administered, and accounted for in
- 8 accordance with applicable law, including, but not
- 9 limited to, the Financial Management Act of 1979. The
- allottee of the funds appropriated under subsection[s]
- 11 (1) $[\frac{}{}, (6), (7), (8) \text{ and } (9)]$ of section 1 of this act
- 12 shall be the Secretary of Education. The allottee of
- the funds appropriated under subsection (2) of section 1
- of this act shall be the Executive Director of the
- 15 Mortlock Development Commission or his designee. The
- 16 allottee of the funds appropriated under subsection (3)
- of section 1 of this act shall be the Northern Namoneas
- 18 Development Authority. The allottee of the funds
- appropriated under subsection (4) of section 1 of this

1 act shall be the Southern Namoneas Development 2 Authority. The allottee of the funds appropriated under subsection (5) of section 1 of this act shall be the 3 4 Pattiw Development Authority. The allottee of the funds 5 appropriated under subsections (6), (7), (8) and (9) of section 1 of this act shall be the Chuuk State 6 7 Commission on Improvement Projects. The allottee of the 8 funds appropriated under section 2 of this act shall be 9 the Governor of the State of Kosrae. The allottee of 10 the funds appropriated under subsections (1), (3) and (4) of section 4 of this act shall be the Governor of 11 12 the State of Yap. The allottee of the funds 13 appropriated under subsection (2) of section 4 of this 14 act shall be the President of the College of Micronesia-The allottee of all other funds appropriated by 15 16 this act shall be the President of the Federated States 17 of Micronesia or the President's designee. 18 allottees shall be responsible for ensuring that these 19 funds, or so much thereof as may be necessary, are used 20 solely for the purposes specified in this act, and that 21 no obligations are incurred in excess of the sum 22 appropriated.
