#### AN ACT

To further amend Public Law No. 11-59, as amended, by amending section 1 to change the use of certain funds for Kosrae State, by amending section 3 to change the use of certain funds for Chuuk State, by amending section 7 to change the allottees for certain funds appropriated for Chuuk and Kosrae States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 1 of Public Law No. 11-59, as amended by

4	Section 3. Section 7 of Public Law No. 11-59, as amended by
5	Public Laws Nos. 11-69, 11-79 and 12-7, is hereby further amended
6	to read as follows:
7	"Section 7. Allotment and management of funds and lapse
8	<u>date</u> .
9	(1) All funds appropriated by this act shall be
10	allotted, managed, administered, and accounted for in
11	accordance with applicable law, including, but not
12	limited to, the Financial Management Act of 1979. The
13	allottee of the funds appropriated under subsection (1)
14	of section 1 of this act shall be the Chairman of the
15	Coordination Committee of the Kosrae State 2001 Summer
16	Youth Conference. The allottee of the funds
17	appropriated under subsections $(2)$ , $(4)$ , $(5)$ , $(10)$ and
18	(11) of section 1 of this act shall be the Secretary of
19	the Department of Finance and Administration, or his
20	designee. The allottee of the funds appropriated under
21	subsection (3) of section 1 and the funds appropriated
22	under section 6 of this act shall be the Governor of the
23	State of Kosrae, or his designee. The allottees of the
24	funds appropriated under subsections (6) through (9) of
25	section 1 of this act shall be the Mayors of the

respective towns or municipalities. The allottee of the funds appropriated under sections 2 and 5 of this act shall be the President of the Federated States of Micronesia, or his designee. The allottee of the funds appropriated under section 3 of this act shall be the Chuuk State Commission on Improvement Projects, EXCEPT THAT the allottee of the\_funds appropriated under subsection (2)(b) of section 3 of this act shall be the Vice President of the Federated States of Micronesia, or his designee; and the allottee of the funds appropriated under subsection (6) of section 3 of this act shall be the Northwest Project Coordinator. The allottee of the funds appropriated under subsections (1) through (13) and subsection (15) of section 4 of this act shall be the Governor of the State of Yap, or his designee. allottee of the funds appropriated under subsection (14) of section 4 of this act shall be the Speaker of the Congress of the Federated States of Micronesia, or his designee. The allottees shall be responsible for ensuring that the funds appropriated by this act, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum appropriated.
