- 15 workers and other occupants of the three buildings attacked, and
- 16 passengers and crew members in the four airliners were killed or
- 17 maimed, and frightened beyond belief, and their families and loved
- 18 ones have suffered great and grievous loss; now, therefore,
- 19 BE IT RESOLVED by the Twelfth Congress of the Federated
- 20 States of Micronesia, Second Regular Session, 2001, that the
