

A BILL FOR AN ACT

To further amend Public Law No. 9-100, as amended, by further amending section 5, as amended by Public Laws Nos. 9-104, 9-137, 9-151, 10-20, 10-44, 10-73, 10-116 and 10-117, to change the allottee for Chuuk Election District No. 3 projects, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1           Section 1. Section 5 of Public Law No. 9-100, as amended by  
2 Public Laws Nos. 9-104, 9-137, 9-151, 10-20, 10-44, 10-73, 10-116 and  
3 10-117, is hereby further amended to read as follows:

4           "Section 5. Allotment and management of funds and lapse  
5 date.

6           (1) All funds appropriated by this act shall be allotted,  
7 managed, administered, and accounted for in accordance with  
8 applicable law, including, but not limited to, the Financial  
9 Management Act of 1979. The allottee of the funds  
10 appropriated under subsection (1) of section 1 of this act  
11 shall be the Governor of the State of Chuuk. The allottee of  
12 the funds appropriated under subsection (2)(a), (2)(b),  
13 (2)(c) and (2)(d) of section 1 of this act shall be the  
14 Teleisom Authority. The allottees of the funds appropriated  
15 under subsection (2)(e) and (2)(f), except for funds  
16 appropriated under subsection (2)(e)(iv) and (2)(f)(iv), of  
17 section 1 of this act shall be the mayors of the respective  
18 municipalities. The allottee of the funds appropriated under

1 subsection (2)(e)(iv), (2)(f)(iv), (2)(g), (2)(h) and (2)(i)  
2 of section 1 of this act shall be the mayor of Polle  
3 Municipality. The allottee of the funds appropriated under  
4 subsection (3) of section 1 of this act shall be the  
5 [~~Southern Namoneas Development Authority~~] Chuuk State  
6 Commission on Improvement Projects. The allottee of the  
7 funds appropriated under subsections (4) and (8) of section 1  
8 of this act shall be the Northern Namoneas Development  
9 Authority. The allottee of the funds appropriated under  
10 subsection (5) of section 1 of this act shall be the Mortlock  
11 Development Authority. The allottee of the funds  
12 appropriated under subsection (6)(a) of section 1 of this act  
13 shall be the Halls Project Coordinator. The allottee of the  
14 funds appropriated under subsection (6)(b) of section 1 of  
15 this act shall be the Weito Project Coordinator. The  
16 allottee of the funds appropriated under subsections (6)(c)  
17 and (6)(d) of section 1 of this act shall be the Pattiw  
18 Development Authority. The allottee of the funds  
19 appropriated under subsection (6)(e) of section 1 of this act  
20 shall be the Northwest Islands Project Coordinator. The  
21 allottee of the funds appropriated under subsection (7) of  
22 section 1 of this act shall be the Speaker of the Congress of  
23 the Federated States of Micronesia or the Speaker's designee.  
24 The allottee of the funds appropriated under subsection (2)  
25 of section 2 of this act shall be the Chairman of the Kosrae

1 Utilities Authority, and the allottee of the funds  
2 appropriated under subsection (9) of section 2 of this act  
3 shall be the Governor of the State of Kosrae. The allottee  
4 of the funds appropriated under subsection (1)(a)(i) of  
5 section 3 of this act shall be the Mayor of Kolonia Town.  
6 The allottee of the funds appropriated under subsections  
7 (1)(a)(ii)a), (1)(a)(ii)b), and (1)(a)(ii)c) of section 3 of  
8 this act shall be the Pohnpei Transportation Authority. The  
9 allottee of the funds appropriated under subsection  
10 (1)(a)(ii)d) of section 3 of this act shall be the Chief  
11 Magistrate of Sokehs Municipality. The allottee of the funds  
12 appropriated under subsection (1)(b) of section 3 of this act  
13 shall be the Vice President of the Federated States of  
14 Micronesia or the Vice President's designee. The allottee of  
15 the funds appropriated under subsection (2)(a) and (2)(b) of  
16 section 3 of this act shall be the Pohnpei Visitor's Bureau.  
17 The allottee of the funds appropriated under subsections (1)  
18 and (3) of section 4 of this act shall be the Governor of the  
19 State of Yap. The allottee of all other funds appropriated  
20 by this act shall be the President of the Federated States of  
21 Micronesia or the President's designee. The allottees shall  
22 be responsible for ensuring that these funds, or so much  
23 thereof as may be necessary, are used solely for the purpose  
24 specified in this act, and that no obligations are incurred  
25 in excess of the sum appropriated. The allottees of the

1 funds appropriated under subsection (1)(a) and (1)(b) of  
2 section 3 of this act shall not obligate any funds  
3 appropriated therein without first consulting with the member  
4 of the Pohnpei Delegation to Congress representing the  
5 Election District to which the funds are apportioned. The  
6 allottees of funds appropriated under subsection (1)(a) of  
7 section 3 of this act shall not obligate or expend any funds  
8 apportioned under said subsection for travel.

9 (2) The authority of the allottees to obligate funds  
10 appropriated by this act shall not lapse."

11 Section 2. This act shall become law upon approval by the  
12 President of the Federated States of Micronesia or upon its becoming  
13 law without such approval.
