

A BILL FOR AN ACT

To amend Public Law No. 6-113 by amending sections 2 and 3 thereof for the purpose of reallocating certain funds, for changing the allottee of certain funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 6-113 is hereby  
2 amended to read as follows:

3 "Section 2. The sum of \$8,227, or so much thereof as  
4 may be necessary, is hereby appropriated from the  
5 General Fund of the Federated States of Micronesia for  
6 the fiscal year ending September 30, 1991, for the  
7 purpose of funding Kitti public projects and programs.  
8 The funds appropriated under this section shall be  
9 apportioned as follows:

- 10 (1) Wone water system..... \$~~[142]~~ -0-
- 11 (2) Rohnkitti to Pwok water system..... [~~162~~] -0-
- 12 (3) Nanmahnd Youth Organization..... [~~372~~] -0-
- 13 (4) Mwudok Youth Organization..... [~~532~~] -0-

15 vehicle repair ..... 2,308
- 16 (6) Office of Pwihnen Wahu operations and  
17 vehicle ..... [~~2,800~~] -0-

8 Section 2. Section 3 of Public Law No. 6-113 is hereby  
9 amended to read as follows:

10 "Section 3. Allotment and management of funds and lapse  
11 date.

12 (1) All funds appropriated by this act shall be  
13 allotted, managed, administered, and accounted for in  
14 accordance with applicable law, including, but not  
15 limited to, the Financial Management Act of 1979. The  
16 allottee of the funds appropriated under section 1 of  
17 this act shall be the Menin Keder Lapalap of the  
18 Madolenihmw Municipal Government, except for those funds  
19 appropriated under subsection (7) of section 1 of this  
20 act for which the allottee shall be the Menin Keder  
21 Lapalap of the Madolenihmw Municipal Government and the  
22 Menin Tiensapw of Madolenihmw. The allottee of the  
23 funds appropriated under section 2 of this act shall be  
24 the Luhken Menlap of the Kitti Municipal Government,  
25 except for those funds appropriated under subsection (7)

1 of section 2 of this act for which the allottee shall be  
2 the Luhken Menlap of the Kitti Municipal Government and  
3 the Isokohnedi of Kitti. The President of the Federated  
4 States of Micronesia shall be the allottee for the funds  
5 appropriated under subsection (10) of section 2 of this  
6 act. The allottees shall be responsible for ensuring  
7 that these funds, or so much thereof as may be  
8 necessary, are used solely for the purpose specified in  
9 this act, and that no obligations are incurred in excess  
10 of the sum appropriated.

11 (2) The authority of the allottees to obligate funds  
12 appropriated by this act shall not lapse."

13 Section 3. This act shall become law upon approval by the  
14 President of the Federated States of Micronesia or upon its  
15 becoming law without such approval.
