
A BILL FOR AN ACT

To further amend Public Law No. 9-052, as amended, by amending section 6 to change the allottee of certain funds appropriated for Chuuk State Election District No. 1, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 9-052, as amended by
2 Public Laws No. 9-071, 9-094, 9-117, 9-147, 10-69, and 12-030, is
3 hereby further amended to read as follows:

4 "Section 6. Allotment and management of funds and lapse
5 date.

6 (1) All funds appropriated by this act shall be
7 allotted, managed, administered and accounted for in
8 accordance with applicable law, including, but not
9 limited to, the Financial Management Act of 1979. The
10 allottee of the funds appropriated under subsections
11 (1)(a) and (1)(b) of section 1 of this act shall be the
12 President of the Federated States of Micronesia. The
13 allottee of the funds appropriated under subsection
14 (1)(c) of section 1 of this act shall be the Governor of
15 the State of Chuuk. The allottee of the funds
16 appropriated under subsection (1)(d) of section 1 of
17 this act shall be the Director of the Department of
18 Health Services, Chuuk State. The allottee of the funds
19 appropriated under subsection (2) of section 1 of this

1 act shall be the executive director of the Chuuk Housing
2 Authority. The allottee of the funds appropriated under
3 subsection (3) of section 1 of this act shall be the
4 Executive Director of the Mortlock Development
5 Commission [~~Vice President of the Federated States of~~
6 ~~Micronesia~~], or his designee. The allottee of the funds
7 appropriated under subsection (4) of section 1 of this
8 act shall be the Executive Director of the Chuuk State
9 Commission on Improvement Projects. The allottee of the
10 funds appropriated under subsections (5) (a), (5) (b) and
11 (5) (c) of section 1 of this act shall be the Tolensom
12 Authority. The allottee of the funds appropriated under
13 subsections (5) (d), (5) (e), (5) (f) and (5) (g) of section
14 1 of this act shall be the Mayor of Polle Municipality.
15 The allottee of the funds appropriated under subsection
16 (6) of section 1 of this act shall be the Northern
17 Namoneas Development Authority. The allottee of the
18 funds appropriated under subsection (7) of section 1 of
19 this act shall be the Northwest Islands Project
20 Coordinator. The allottee of the funds appropriated
21 under subsections (1) (b) (i) and (1) (b) (iii) of section 2
22 of this act shall be the National Planner of the
23 Federated States of Micronesia. The allottee of the
24 funds appropriated under subsections (1) (b) (ii) and
25 (1) (b) (v) of section 2 of this act shall be the Chief

1 Magistrate of Sokehs. The allottee of the funds
2 appropriated under subsections (1)(b)(iv) of section 2
3 of this act shall be the National Planner of the
4 Federated States of Micronesia. The allottee of the
5 funds appropriated under subsection (1)(c) of section 2
6 of this act shall be the Mayor of Kolonia Town. The
7 allottee of the funds appropriated under subsection
8 (1)(d) of section 2 of this act shall be President of
9 the Federated States of Micronesia or his designee. The
10 allottee of the funds appropriated under subsection
11 (1)(e) of section 2 of this act shall be the Chief
12 Magistrate of Nukuoro. The allottee of the funds
13 appropriated under subsection (1)(f) of section 2 of
14 this act shall be the Pohnpei Port Authority. The
15 allottee of the funds appropriated under subsections
16 (1)(a) and (3) of section 2 and subsections (2) and (3)
17 of section 3 of this act shall be the President of the
18 Federated States of Micronesia or his designee, except
19 that the allottee of the funds appropriated under
20 subsections (3)(a), (3)(b), (3)(c) and (3)(d) of section
21 2 of this act shall be the Pohnpei Transportation
22 Authority. The allottee of the funds appropriated under
23 subsections (1) and (4) of section 3 of this act shall
24 be the Governor of the State of Kosrae or his designee.
25 The allottee of the funds appropriated under subsections

1 (5) (a), (7) and (8) of section 3 of this act shall be
2 the Mayor of Lelu Municipality. The allottee of the
3 funds appropriated under subsection (5) (b) of section 3
4 of this act shall be the Mayor of Tafunsak Municipality.
5 The allottee of the funds appropriated under subsection
6 (5) (c) of section 3 of this act shall be the Mayor of
7 Utwe Municipality. The allottee of the funds
8 appropriated under subsection (5) (d) of section 3 of
9 this act shall be the Mayor of Malem Municipality. The
10 allottee of the funds appropriated under subsection (6)
11 of section 3 of this act shall be the Speaker of the
12 Congress of the Federated States of Micronesia or his
13 designee. The allottee of the funds appropriated under
14 subsection (6) of section 4 of this act shall be the
15 Mayor of Rull Municipality. The allottee of the funds
16 appropriated under the other subsections of section 4 of
17 this act shall be the Governor of the State of Yap or
18 his designee. The allottees of funds apportioned under
19 subsection (1) of section 2 of this act shall not
20 obligate or expend any of said funds for travel. The
21 allottees shall be responsible for ensuring that these
22 funds, or so much thereof as may be necessary, are used
23 solely for the purpose specified in this act, and that
24 no obligations are incurred in excess of the sum
25 appropriated.

1 (2) The authority of the allottees to obligate funds
2 appropriated by this act shall not lapse."
3

1 Section 2. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
