
A BILL FOR AN ACT

To further amend Public Law No. 10-143, as amended, by amending section 5 to change the allottee of certain funds appropriated for Chuuk State Election District No. 1, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 10-143, as amended by
2 Public Laws No. 12-22 and 12-31, is hereby further amended to
3 read follows:

4 "Section 5. Allotment and management of funds and lapse
5 date.

6 (1) All funds appropriated by this act shall be
7 allotted, managed, administered, and accounted for in
8 accordance with applicable law, including, but not
9 limited to, the Financial Management Act of 1979. The
10 allottee of the funds appropriated under section 1(1) of
11 this act shall be the Executive Director of the Mortlock
12 Development Commission~~[Vice President of the Federated~~
13 ~~States of Micronesia]~~, or his designee. The allottee of
14 the funds appropriated under section 1(2) of this act
15 shall be the Executive Director of the Northern Namoneas
16 Development Authority or his designee. The allottee of
17 the funds appropriated under section 1(3) of this act
18 shall be the Executive Director of the Chuuk State
19 Commission on Improvement Projects. The allottee of the

1 funds appropriated under section 1(4) of this act shall
2 be the Mayor of Polle. The allottee of the funds
3 appropriated under section 1(5) of this act shall be the
4 Northwest Islands Project Coordinator or his designee.
5 The allottee of the funds appropriated under section
6 1(6) of this act shall be the Secretary of the
7 Department of Health, Education and Social Affairs of
8 the Federated States of Micronesia, or his designee.
9 The allottee of the funds appropriated under section
10 2(1)(b) of this act shall be the Mayor of Kolonia. The
11 allottee of the funds appropriated under section 3 of
12 this act shall be the Governor of the State of Yap or
13 the Governor's designee. The allottee of the funds
14 appropriated under section 4 of this act shall be the
15 Governor of the State of Kosrae or the Governor's
16 designee. The allottee of all other funds appropriated
17 by this act shall be the President of the Federated
18 States of Micronesia or the President's designee. The
19 allottees shall be responsible for ensuring that these
20 funds, or so much thereof as may be necessary, are used
21 solely for the purpose specified in this act, and that
22 no obligations are incurred in excess of the sum
23 appropriated.

24 (2) The authority of the allottees to obligate funds
25 appropriated by this act shall not lapse."

1 Section 2. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
