

A BILL FOR AN ACT

To further amend Public Law No. 10-120, as amended, by amending section 1 thereof to reallocate certain funds appropriated to Election District No. 5 in the State of Chuuk and by amending section 6 thereof to change the allottee for certain funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 10-120, as amended by
2 Public Laws Nos. 10-122, 10-144, 11-8, 11-20, 11-32, 12-6 and 12-
3 20, is hereby further amended to read as follows:

4 "Section 1. The sum of \$5,000,000, or so much thereof
5 as may be necessary, is hereby appropriated from the
6 General Fund of the Federated States of Micronesia for
7 the fiscal year ending September 30, 1999, for the
8 purpose of funding infrastructure and other projects and
9 programs in the State of Chuuk. The funds appropriated
10 under this section shall be apportioned as follows:

11 (1) Regional transportation projects
12 (which shall be deemed to come from capital
13 account funds available under section 211
14 of the Compact of Free Association)

15 (a) Ta airport paving and related
16 structures and equipment\$ 200,000

16 Section 2. Section 6 of Public Law No. 10-120, as amended by
 17 Public Laws Nos. 10-122, 11-8, 11-10, 11-20, 11-32, 11-64, 11-75,
 18 12-20 and 12-47, is hereby further amended to read as follows:

19 "Section 6. Allotment and management of funds and lapse
 20 date.

21 (1) All funds appropriated by this act shall be
 22 allotted, managed, administered, and accounted for in
 23 accordance with applicable law, including, but not
 24 limited to, the Financial Management Act of 1979. The
 25 allottee of the funds appropriated under section 1(3) (e)

1 of this act shall be the Governor of the State of Chuuk
2 or his designee. The allottee of the funds appropriated
3 under section 1(2) of this act shall be the Speaker of
4 the Congress of the Federated States of Micronesia. The
5 allottee of the funds appropriated under section 1(3)(a)
6 of this act shall be the Director of the Department of
7 Health Services. The allottee of the funds appropriated
8 under section 1(3)(c) of this act shall be the Assistant
9 Director, Land Grant Program, Cooperative Extension
10 Services, Chuuk State. The allottee of the funds
11 appropriated under section 1(3)(d) of this act shall be
12 the Executive Director of the Chuuk Recreation Office.
13 The allottee of the funds appropriated under section[s]
14 1(3)(f) [~~and 1(3)(g)~~] of this act shall be the Secretary
15 of the Department of Health, Education and Social
16 Affairs of the Federated States of Micronesia, or his
17 designee. The allottee of the funds appropriated under
18 section 1(4) of this act shall be the Mortlock
19 Development Commission. The allottee of the funds
20 appropriated under sections 1(5) and 1(3)(b) of this act
21 shall be the Executive Director of the Northern Namoneas
22 Development Authority, or if the Northern Namoneas
23 Development Authority shall be abolished, the Northern
24 Namoneas Project Coordinator or his designee. The
25 allottee of the funds appropriated under section 1(6)(b)

1 of this act shall be the Executive Director of the Chuuk
2 State Commission on Improvement Projects. At the
3 beginning of each quarter, the Secretary of the
4 Department of Finance and Administration, or his
5 designee, shall provide a status report to the member of
6 Congress representing Chuuk Election District No. 3 on
7 the Educational and Health Trust Fund created pursuant
8 to section 1(6)(b) of this act. Said report shall
9 describe the investment status of the fund and changes
10 in fund balances since the previous report, including
11 nominal and real rates of return on investments. The
12 allottee of the funds appropriated under section 1(6)(a)
13 and 1(6)(c) of this act shall be the Chuuk State
14 Commission on Improvement Projects. The allottee of the
15 funds appropriated under section 1(7) of this act shall
16 be the Mayor of Polle. The allottee of the funds
17 appropriated under section 1(8) of this act shall be the
18 ~~[Northwest Islands Project Coordinator or his designee]~~
19 Chuuk State Commission on Improvement Projects. The
20 allottee of the funds appropriated under section 2(1) of
21 this act shall be the respective mayor of each
22 municipality listed therein. The allottee of the funds
23 appropriated under sections 2(2) through 2(8) of this
24 act shall be the Governor of the State of Kosrae. The
25 allottee of the funds appropriated under section 2(9) of

1 this act shall be the President of the Federated States
2 of Micronesia, or the President's designee. The
3 allottee of the funds appropriated under section 3(1)(a)
4 of this act shall be the Mayor of Kolonia Town, and said
5 allottee shall obligate no more than \$3,000 of such
6 funds for administrative costs. The allottee of the
7 funds
8 appropriated under sections 4(1) through 4(7), 4(9)
9 through 4(18), and 4(24) of this act shall be the
10 Governor of the State of Yap. The allottee of the funds
11 appropriated under section 4(8) of this act shall be the
12 Speaker of the Congress of the Federated States of
13 Micronesia. The allottee of the funds appropriated
14 under section 4(23) of this act shall be the Secretary
15 of the Department of Health, Education and Social
16 Affairs. The allottee of all other funds appropriated
17 by this act
18 shall be the President of the Federated States of
19 Micronesia or the President's designee. In the event
20 that the President designates the Vice President as
21 allottee, the Vice President may designate a
22 suballottee. The allottees shall be responsible for
23 ensuring that these funds, or so much thereof as may be
24 necessary, are used solely for the purpose specified in
25 this act, and that no obligations are incurred in excess

1 of the sum appropriated. The allottee of the funds
2 appropriated under section 3(2) of this act shall
3 obligate no more than ten percent of such funds for
4 administrative costs.

5 (2) The authority of the allottees to obligate funds
6 appropriated by this act shall not lapse."

7 Section 3. This act shall become law upon approval by the
8 President of the Federated States of Micronesia or upon its
9 becoming law without such approval.
