## A BILL FOR AN ACT

To further amend Public Law No. 13-19, as amended by Public Law 13-35, by amending sections 4 and 9 thereof for the purpose of making certain corrections thereto, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 4 of Public Law No. 13-19, as amended by
- 2 Public Laws Nos. 13-30 and 13-35, is hereby further amended to
- 3 read as follows:
- 4 "Section 4. Operating expenses of the National
- 5 <u>Judiciary Branch</u>.
- 6 The sum of [\$898,767] \$969,071, or so much thereof as
- 7 may be necessary, is hereby appropriated from the
- 8 General Fund of the Federated States of Micronesia for
- 9 the fiscal year ending September 30, 2004, for the
- 10 operations of the
- 11 Judiciary Branch of the National Government during
- 12 fiscal year 2004 in order to achieve the activities set
- forth in the performance budget pages 398 through 400 of
- the budget book."
- 15 Section 2. Section 9 of Public Law No. 13-19, as amended by
- 16 Public Laws Nos. 13-30 and 13-35, is hereby further amended to
- 17 read as follows:
- "Section 9. <u>Capital and Human Resource Development</u>.

1	The sum of \$5,860,595, or so much thereof as may be
2	necessary, is hereby appropriated from the General Fund
3	of the Federated States of Micronesia for the fiscal
4	year ending September 30, 2004, for capital improvement,
5	development programs and projects and human resource
6	development. The sum appropriated under this section
7	shall be apportioned as follows:
8	(1) College of Micronesia-FSM
9	(a) Operations of the College of Micronesia-FSM,
10	including planning, construction and
11	maintenance of college facilities \$ 3,513,000
12	(b) Student assistance for
13	tuition and housing to be deemed as deriving
14	from carryover funds from section 216(a)(3)
15	of the Compact I 475,000
16	(c) COM-FSM Chuuk Campus Facility 350,000
17	(d) FSM Fisheries and Maritime
18	Institute
19	(2) National Staff Upgrading 50,000
20	(3) FSM Visitor Bureau0-
21	(4) EMPAT Phase III 23,500
22	(5) 3 <sup>rd</sup> Convention of FSM Coastal
23	Fisheries 8,702
