BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 8-100, as amended by

amended to read as follows:

The 7 allottee of the funds appropriated under subsections 8 (1), (3) and (4) of section 4 of this act shall be the 9 Governor of the State of Yap. The allottee of the funds 10 appropriated under subsection (2) of section 4 of this 11 act shall be the President of the College of Micronesia-The allottee of all other funds appropriated by 12 FSM. this act shall be the President of the Federated States 13 14 of Micronesia or the President's designee. 15 allottees shall be responsible for ensuring that these 16 funds, or so much thereof as may be necessary, are used 17 solely for the purposes specified in this act, and that 18 no obligations are incurred in excess of the sum 19 appropriated.

(2) The authority of the allottees to obligate funds appropriated by this act shall not lapse."
