BE	IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Section 3 of Public Law No. 13-36, as amended by
2	Public Laws Nos. 13-49 and 13-66, is hereby further amended to

4	"Section 3. The sum of \$800,000, or so much thereof as
5	may be necessary, is hereby appropriated from the
6	General Fund of the Federated States of Micronesia for

Allotment and management of funds and lapse 12 13 date. 14 (1) All funds appropriated by this act shall be allotted, mana allottee of the funds appropriated under sections 1, 2 15 and 3 of this act shall be the President of the 16 Federated States of Micronesia or his designee, except 17 18 that the allottee of the funds appropriated under 19 subsections 1(1), 1(3) and 1(4) of this act shall be the 20 Governor of the State of Kosrae; the allottee of the 21 funds appropriated under sections 2(3) and 2(4) of this 22 act shall be the Governor of the State of Yap; the 23 allottee of the funds appropriated under sections 2(5) 24 and 2(6) shall be the Speaker of Congress; the allottee 25 of the funds appropriated under subsection 3(2)(a)(i)

1 shall be the mayor of Kolonia Town; the allottee of the 2 funds appropriated under subsections 3(2)(a)(ii), 3 3(2)(a)(iv) and 3(2)(a)(v) shall be the Sokehs 4 magistrate; the allottee of the funds appropriated under 5 subsection 3(2)(a)(iii) shall be the mayor of Nukuoro; 6 and the allottee of funds appropriated under subsections 7 3(2)(c)(v) <u>and 3(2)(c)(vi)</u> shall be the Pohnpei 8 Transportation Authority. The allottee of the funds 9 appropriated under section 4 of this act shall be the 10 Chuuk State Commission on Improvement Projects, except 11 that the funds appropriated under section 4(1)(c) of this act shall be allotted to the President of the 12 13 Federated States of Micronesia. 14 (2) The allottees of the funds appropriated herein 1.5 shall be responsible for ensuring that these funds, or 16 so much thereof as may be necessary, are used solely for 17 the purpose specified herein, and shall report back to 18 the Congress on the status of these funds no later than September 30, 2005. The authority of the allottees to 19 20 obligate such funds shall not lapse until fully 21 expended."

Section 3. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
