A BILL FOR AN ACT

To further amend Public Law No. 9-052, as amended, by amending section 6 thereof to change the allottee of certain funds appropriated to Chuuk State, to reenact the lapse provision, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 6 of Public Law No. 9-052, as
- 2 amended by Public Laws Nos. 10-69, 12-30, 12-40, 12-70 and
- 3 13-4, is hereby further amended to read as follows:
- 4 "Section 6. Allotment and management of funds and lapse
- 5 <u>date</u>.
- 6 (1) All funds appropriated by this act shall be
- 7 allotted, managed, administered and accounted for
- 8 in accordance with applicable law, including, but
- 9 not limited to, the Financial Management Act of
- 10 1979. The allottee of the funds appropriated under
- 11 subsection (1)(a) of section 1 of this act shall be
- the Chuuk State Commission on Improvement Projects.
- The allottee of the funds appropriated under
- 14 subsection $\left(\frac{s}{s}\right)$ (1) (a) and (1) (b) of section 1 of this
- 15 act shall be the President of the Federated States
- of Micronesia. The allottee of the funds
- 17 appropriated under subsection (1)(c) of section 1
- 18 of this act shall be the Governor of the State of
- 19 Chuuk. The allottee of the funds appropriated

under subsection (1)(d) of section 1 of this act 1 2 shall be the Director of the Department of Health 3 Services, Chuuk State. The allottee of the funds 4 appropriated under subsection (2) of section 1 of this act shall be the Executive Director of the 5 6 Chuuk Housing Authority. The allottee of the funds 7 appropriated under subsections (3) and (4) of section 1 of this act shall be the Executive 8 9 Director of the Chuuk State Commission on 10 Improvement Projects. The allottee of the funds appropriated under subsections (5)(a), (5)(b) and 11 (5)(c) of section 1 of this act shall be the 12 13 Tolensom Authority. The allottee of the funds 14 appropriated under subsections (5)(d), (5)(e), (5) (f) and (5) (g) of section 1 of this act shall be 15 16 the Mayor of Polle Municipality. The allottee of 17 the funds appropriated under subsection (6) of 18 section 1 of this act shall be the Northern 19 Namoneas Development Authority. The allottee of 20 the funds appropriated under subsection (7) of 21 section 1 of this act shall be the Chuuk State 22 Commission on Improvement Projects. The allottee 23 of the funds appropriated under subsections 24 (1) (b) (i) and (1) (b) (iii) of section 2 of this act 25 shall be the National Planner of the Federated

States of Micronesia. The allottee of the funds 1 2 appropriated under subsections (1)(b)(ii) and 3 (1) (b) (v) of section 2 of this act shall be the 4 Chief Magistrate of Sokehs. The allottee of the 5 funds appropriated under subsections (1) (b) (iv) of 6 section 2 of this act shall be the National Planner 7 of the Federated States of Micronesia. 8 allottee of the funds appropriated under subsection 9 (1) (c) of section 2 of this act shall be the Mayor 10 of Kolonia Town. The allottee of the funds appropriated under subsection (1)(d) of section 2 11 of this act shall be President of the Federated 12 13 States of Micronesia or his designee. The allottee 14 of the funds appropriated under subsection (1)(e) of section 2 of this act shall be the Chief 15 16 Magistrate of Nukuoro. The allottee of the funds 17 appropriated under subsection (1)(f) of section 2 18 of this act shall be the Pohnpei Port Authority. 19 The allottee of the funds appropriated under 20 subsections (1)(a) and (3) of section 2 and 21 subsections (2) and (3) of section 3 of this act 22 shall be the President of the Federated States of 23 Micronesia or his designee, except that the 24 allottee of the funds appropriated under 25 subsections (3)(a), (3)(b), (3)(c) and (3)(d) of

1 section 2 of this act shall be the Pohnpei 2 Transportation Authority. The allottee of the 3 funds appropriated under subsections (1) and (4) of 4 section 3 of this act shall be the Governor of the 5 State of Kosrae or his designee. The allottee of 6 the funds appropriated under subsections (5)(a), 7 (7) and (8) of section 3 of this act shall be the 8 Mayor of Lelu Municipality. The allottee of the 9 funds appropriated under subsection (5)(b) of 10 section 3 of this act shall be the Mayor of Tafunsak Municipality. The allottee of the funds 11 appropriated under subsection (5)(c) of section 3 12 13 of this act shall be the Mayor of Utwe 14 Municipality. The allottee of the funds 15 appropriated under subsection (5)(d) of section 3 16 of this act shall be the Mayor of Malem 17 Municipality. The allottee of the funds appropriated under subsection (6) of section 3 of 18 19 this act shall be the Speaker of the Congress of 20 the Federated States of Micronesia or his designee. 21 The allottee of the funds appropriated under 22 subsection (6) of section 4 of this act shall be 23 the Mayor of Rull Municipality. The allottee of 24 the funds appropriated under the other subsections 25 of section 4 of this act shall be the Governor of

the State of Yap or his designee. The allottees of 1 funds apportioned under subsection (1) of section 2 3 of this act shall not obligate or expend any of 4 said funds for travel. The allottees shall be 5 responsible for ensuring that these funds, or so 6 much thereof as may be necessary, are used solely 7 for the purpose specified in this act, and that no 8 obligations are incurred in excess of the sum 9 appropriated. 10 (2) The authority of the allottees to obligate funds 11 appropriated by this act shall not lapse. 12 Section 2.
