## A BILL FOR AN ACT

To further amend title 2 of the Code of the Federated States of Micronesia, as amended, to require that the President of the Federated States of Micronesia appoints Ambassadors, permanent members of the Joint Economic Management Committee and Joint Trust Fund Committee with the advice and consent of the Congress of the Federated States of Micronesia, limiting the term of Ambassadors to the term of the President, to provide an effective date for the resignation of ambassadors, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

appointed by the President; [and including] 1 2 (f) the Federated States of Micronesia members of 3 the Board of Regents of the College of Micronesia; (g) the permanent members, if any, of the Joint 4 5 Economic Management Committee and Joint Trust Fund 6 Committee created pursuant to the Amended Compact of Free Association between the United States of America 7 and the Federated States of Micronesia; and [including 8 the Federated States of Micronesia's deputy ambassadors 9 10 (assistants to the ambassadors) and 11 (h) consuls general; provided that nothing herein 12 shall be construed to require the appointment of the 13 deputies [and deputy ambassadors (assistant to the 14 ambassadors) and consuls general named above. 15 (2) The President or his or her designee may appoint officers and employees not included in subsection (1) of 16 17 this section, without the advice and consent of the 18 Congress; provided that such appointments are not 19 inconsistent with the provisions of this chapter or 20 other laws of the Federated States of Micronesia. 21 (3) Any nomination submitted to Congress which is not 22 acted upon within two (2) consecutive sessions of 23 Congress, not including the session in which Congress first receives the nomination, or ninety (90) days, 24 25 whichever occurs later in time, shall be deemed

rejected. The President shall not resubmit the nomination of any person to the Congress for its action if the same Congress shall have previously rejected such nomination, unless the Congress shall by resolution authorize such resubmission.

(4) With the exception of the Chief Justice and Associate Justices of the Supreme Court, the Public Auditor, [ambassadors,] members of boards, commissions, and other entities with fixed terms, a public official whose appointment is subject to the advice and consent of the Congress shall submit his or her resignation no later than (90) ninety days after the President of the Federated States of Micronesia takes the oath of office, or at the time a new nominee for such position is confirmed by the Congress, whichever is earlier. President may re-nominate the same public official for the same position subject to the advice and consent of the Congress. With respect to the (90) ninety day resignation requirement for ambassadors, the provisions of this subsection shall become effective as of May 11, <u>2007.</u>"
