Dear Mr. Speaker:

Your Committee on External Affairs, to which was jointly referred the National Government's proposed FY 2005 Budget, begs leave to report as follows:

The FY 2005 Proposed Budget Book, transmitted by the Executive on April 1, 2004, details the National Government's proposed budget for Fiscal Year 2005. Pursuant to rule 7, section 5(b), of the Official Rules of Procedure of the Thirteenth Congress of the Federated States of Micronesia, your committee has limited its review to those portions relating to matters under its jurisdiction. Those portions include:

I. The Department of Foreign Affairs, including the Office of the Secretary, the Division of Asian, Pacific, African and Multilateral Affairs, the Division of American and European Affairs, and the FSM embassies and consulates abroad (together the "Department");

II. The National Authorizing Committee (ACP/EU); and

III. Subsidies and contributions to the Forum Secretariat; the Pacific Community; the United Nations Economic and Social Commission for Asia and the Pacific (ESCAP); the United Nations Secretariat; the East West Center; and the Cotonou Membership Fee.

Your committee conducted hearings with the Department to consider its budget request on May 15, 2004.

Based upon the hearing and further deliberations, this Standing Committee Report reflects the final recommendations of your Committee on External Affairs regarding the proposed FY 2004 Budget. Accordingly, your committee offers the following recommendations.

I. Department of Foreign Affairs.

Your committee notes that there is an increase of over \$300,000 in the recommended FY2005 budget over the Department's current FY2004 Budget. The committee understands the critical importance of the Department's mission and the necessity of funding its essential functions and duties as generally prescribed by Article X (2), (b) of the FSM Constitution and Section 503, of Title 10 of the Code of the Federated States of Micronesia. As the authority to conduct foreign relations function for and on behalf of this nation and for all levels of governments in this nation, the Department fulfills an invaluable role that may not be delegated to the other levels of governments in the Federated States of Micronesia. We also recognize that the Department's mission will continue to gain importance as time passes. Nevertheless, the Department must play its part along with the other agencies and branches of this government in reducing costs and doing and accomplishing more with less.

To that end, your committee has the following specific comments.

(1) Consistent with sound fiscal responsibility to cut and minimize costs, the Department should carefully review its travel requirements. As noted in the proposed budget and based on your committee's review, there are areas where it is feasible to consolidate purposes of trips so that one trip may be utilized to address a number of issues in one trip. Any and all official travel undertaken must be directly focused on purposes that serve the interests of the nation in its conduct of foreign affairs. The Department should also be cognizant of the requirement that Government itineraries should utilize the most direct and most economic travel plans available. Foreign mission personnel should be utilized where possible in place of home office personnel to cut travel expenses. That being said, the committee has grave concerns regarding the current use of travel funds by the overseas missions and the Department as a whole. The committee recommends that the Secretary carefully review the destinations, purpose and duration of each travel

request and determine whether undertaking such travel is truly necessary to fulfill the Department's duties and obligations. In summary, the Department should seek ways and means to avoid travel by multiple officials and of redundant travel to the same destinations. All travel must be prioritized and performed according to an established plan and produce outputs supporting established goals, policies, objectives and performance outcomes consistent with the FSM economic development priorities and fiscal realities.

(2) The Department should continue to seek a permanent solution to the problem of currency fluctuations that impacts the operations, administration and management of the Tokyo and Fiji embassies as per their approved budget and now, with our expanding foreign affairs in Europe, with respect to the Euro-dollar. The committee would reiterate its recommendation in FY2004 budget, that the Department explore the possibility of establishing a "*hedging account*" with one of our money managers to offset losses in the value of the US Dollar against the currencies in the respective countries. Any of our money managers should be able to quickly determine whether this is a viable solution and propose a program to address the matter. Although this issue has been raised in prior years, the Committee understands that there has not been any solution established yet to address this ongoing problem. For this reason, your Committee recommends that, while we are awaiting some sort of solution to be found the Congress authorize a built-in percentage amount against the total budget authorized for the affected offices. This hedging fund percentage should be set at up to 15% of each office budget and can only be used when there is a downside fluctuation of US dollars at a host country. Your Committee further recommends that, prior to the implementation of this recommendation, the President, through the Department of Foreign Affairs, should promulgate and adopt rules and regulation in relation to the use and administration of the "Hedging Fund" percentage.

(3) The committee notes that there are still some areas in the proposed budget submission that remain to be clearly explained and justified by the Department. For example: 1) Justification of salary increases in the Tokyo Embassy; 2) Travel that is slated as "State Visits" without explanation and justification.

(4) The Department should continue to expand its efforts to utilize its contacts and resources to promote the economic programs of the FSM. The committee would hope that the Department improves its

cooperation with the Department of Economic Affairs, the National Oceanic Resource Management Authority and all other economic-related agencies and offices to coordinate efforts to accomplish the nation's economic goals.

(5) The committee reiterates its FY2004 recommendation supporting the continued expansion of formal diplomatic relations with other nations. Specifically, the committee would recommend expansion of our relations with nations within the European Union. The committee was informed that a number of European governments and non-governmental organizations offered assistance during the deadly typhoon that struck Chuuk State earlier this year. Some of the assistance was lost because we had no means to coordinate with the donor organizations. The committee believes that an expanded presence in Europe would help to avoid this kind of problem in the future and enhance our access to other development and aid opportunities.

Of course the committee is aware of the significant financial constraints facing the Department at this time. Thus, the committee would request that the Department explore alternatives to establishing resident missions to these countries, including establishing honorary consuls where appropriate.

(6) The committee notes that the Amended Compact of Free Association has now been ratified. We understand that informal negotiation and lobbying efforts will continue during implementation period. Nevertheless, the committee believes that it is appropriate at this time to review the various duties of the various personnel involved in the negotiations to determine which positions, including the legal counsel and lobbyists, may be scaled back or phased out. The committee requests that the Department undertake this task in cooperation with members of the Joint Committee on Compact Economic Negotiations and report its recommendations to the committee at the earliest possible opportunity.

(7) The committee recommends that the Department reevaluate the current pay rates of members of the foreign missions. The committee believes that the pay levels may be excessive in some instances. The National Government must seek to curb expenses where it can. The committee believes that this area is ripe for review.

(8) The committee urges the Secretary to ensure that, with specific emphasis on the Consulate in Guam, Honolulu and the Embassy in Washington D.C., each state is represented in the staff membership of each embassy and consulate office. The committee is confident that Department personnel are equally professional and courteous to every FSM citizen, regardless of origin. Nevertheless, some citizens are more comfortable with persons with whom they share a common language and customs. The committee believes that the Department should be particularly sensitive to this issue as many visitors to our foreign missions are in unfamiliar surroundings and/or under stress from the matter that prompted them to contact Department personnel.
