#### AN ACT

7	appropriated.
8	(2) The authority of the allottee to obligate funds
9	appropriated by this act shall lapse September 30,
10	2006."
11	Section 3. This act shall become law upon approval by the
12	President of the Federated States of Micronesia or upon it
13	becoming law without such approval.
