PUBLIC LAW NO. 14-3

AN ACT

To amend Public Law No. 13-84, by amending section 1 thereof to change the use of certain funds appropriated therein, and for other purposes. BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. Section 1 of Public Law No. 13-84 is hereby 2 amended to read as follows: 3 "Section 1. The sum of \$240,000, or so much thereof as may be necessary, is hereby appropriated 4 5 from the fund entitled 'Public Projects for Chuuk Election District No. 5' within the General Fund, 6 to provide funding for public projects in Chuuk 7 8 Election District No. 5. The funds appropriated 9 under this section shall be apportioned as follows: 10 (1) Junior high school hot lunch\$ 5,000 (2) Tuition, room and board assistance for 11 12 students for the Northwest region of Chuuk 13 at the College of Micronesia main campus ... 16,100 (3) Strategy/planning meeting of the 14 leaders of the Northwest region 15 16 (a) POL and charter boats 20,000 17 (b) Travel allowance and rental 5,000 18 (c) Supplies and materials 1,500 19 (d) Venue rental and refreshments ... 2,900 20 (4) Replanting and rehabilitation project for all thirteen islands in Halls, Weito and Pattiw Islands 21
