## AN ACT

To appropriate the sum of \$119,248 from the General Fund of the Federated States of Micronesia for the purpose of funding public projects and programs in the States of Chuuk and Pohnpei, and for other purposes. BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 1. Purpose. A certain number of project 1 2 appropriations lapsed on June 30, 2006 in accordance to Public Law 3 No. 14-35. The purpose of this bill is to appropriate from the General Fund of the Federated States of Micronesia a corresponding 4 5 amount. 6 Section 2. The sum of \$119,248 is hereby appropriated from the General Fund of the Federated States of Micronesia to fund 7 8 public projects and social programs in the States of Chuuk and 9 Pohnpei. The funds appropriated under Section 2 of this act shall 10 be apportioned as follows: 11 (1) State of Chuuk .....\$ 96,884 12 (a) Election District No. 1 (i) Students' financial assistance 5,000 13 14 (ii) Community Center Renovation 8,000 15 (ii) Mortlock Development Commission 5,000 16 (iv) Delegation Office operation 9,300 17 (b) Election District No. 3 18 (i) Medical supplies ..... 15,000 (ii) Student's financial assistance \$ 34,072 19

8	All funds appropriated by this act shall be allotted, managed,							
9	administered and accounted for in accordance with applicable laws,							
10	including, but not limited to, the Financial Management Act of							
11	1979 and the amended Compact of Free Association between the							
12	United States Government and the Government of the Federated							
13	States of Micronesia and its related agreements. The allottee							
14	shall be responsible for ensuring that these funds, or so much							
15	thereof as may be necessary, are used solely for the purpose							
16	specified in this act, and that no obligations are incurred in							
17	excess of the sum appropriated. The allottee of funds							
18	appropriated under subsection 1 of Section 2 of this Act shall be							
19	the Chuuk State Commission Improvement Project. The allottee of							
20	the funds appropriated under subsection 2 of Section 2 of this Act							
21	shall be the President of the Federated States of Micronesia. The							
22	authority of the allottee to obligate funds appropriated by this							
23	act shall lapse on 30 September, 2008.
