PUBLIC LAW 14-13

AN ACT

To further amend Public Law No. 8-115, as amended, by amending section 1 to change the use of certain funds for the State of Chuuk, and for other purposes. BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 1. Section 1 of Public Law No. 8-115, as amended by 1 2 Public Laws Nos. 10-2, 10-66, 11-51, 12-32, and 12-55, is hereby 3 further amended to read as follows: "Section 1. The sum of \$500,000, or so much thereof as 4 5 may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for 6 7 the fiscal year ending September 30, 1995, to assist 8 State-administered public health programs and for other 9 public projects and programs in the State of Chuuk.
