## AN ACT

To further amend Public Law No. 13-46, as amended, by amending section 13 thereof, to extend the lapse date of certain funds appropriated by Congress, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 13 of Public Law No. 13-46, amended by
- 2 Public Law No. 14-10, is hereby further amended to read as
- 3 follows.
- 4 "Section 13. <u>Allotment and management of funds and lapse</u>
- 5 date.
- 6 (1) General Provisions.

States of Micronesia.

- (a) All funds appropriated by this act shall be
  allotted, managed, administered, and accounted for in
  accordance with applicable law, including, but not
  limited to, the Financial Management Act of 1979 and the
  Amended Compact of Free Association between the United
  States Government and the Government of the Federated
  - (b) The allottees shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purposes specified in this act, and that no obligations are incurred in excess of the sum appropriated.
- 19 (2) Allottees. The allottees of the funds 20 appropriated by this act are as follows:

1	(a) section 2 - the allottee of these funds shall
2	be the President of the Federated States of Micronesia;
3	(b) section 3 - the allottee of these funds shall
4	be the Speaker of the Congress of the Federated States of
5	Micronesia;
6	(c) section 4 - the allottee of these funds shall
7	be the Chief Justice of the Supreme Court of the
8	Federated States of Micronesia;
9	(d) section 5 - the allottee of these funds shall
10	be the Public Auditor of the Federated States of
11	Micronesia;
12	(e) section 6 through 9 - the allottee of these
13	funds shall be the President of the Federated States of
14	Micronesia; EXCEPT THAT for the following subsections of
15	section 6 through 9 of this act, the allottees shall be:
16	(i) section 8, subsection (6)(a) through
17	(6)(d) - the allottee of these funds shall be the Chief
18	Justice of the respective state;
19	(ii) section 9, subsection (1)(a) through
20	(1)(d) - the allottee of these funds shall be the
21	President of the College of Micronesia-FSM;
22	(3) Lapse Dates. The authority of the allottees to
23	obligate funds appropriated by this act shall lapse as of
24	September 30, 2005, EXCEPT that the sum of \$49,000
25	appropriated under section 4 of this act for the 11 <sup>th</sup> FSM

1	Judiciary Conference shall lapse as of November 30, 2006,
2	the sum of \$450,000 appropriated under section 8(5)(f)
3	for site clearance for projects funded by Chinese grant-
4	aid shall lapse as of September 30, 2006 and funds
5	appropriated under section 9 and subsection 8(7)(m) of
6	this act shall not lapse."
