

AN ACT

To further amend Public Law No. 13-46, as amended, by amending sections 2, 3 and 9 thereof for the purpose of appropriating an additional sum of \$1,200,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2005, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 13-46, as amended by
2 Public Law No. 13-62, 13-81 and 13-87, is hereby further amended
3 to read as follows:

4 "Section 2. Operating expenses of the Executive Branch.

5 The sum of \$13,862,322, or so much thereof as may be
6 necessary, is hereby appropriated from the General Fund
7 of the Federated States of Micronesia for the fiscal
8 year ending September 30, 2005, for the operations of
9 the Executive Branch of the National Government during
10 fiscal year 2005. The sum appropriated by this section
11 shall be apportioned as follows:

12 (1) Office of the President
13 \$700,864, for the activities set forth in the
14 performance budget pages 1 through 2 of the budget book.
15 Of the funds appropriated, \$35,000 shall be deemed to
16 come from carryover funds available under section
17 215(a)(2) of Compact I for communications.

18 (2) Department of Foreign Affairs
19 \$3,426,792 for the activities set forth in the

1 performance budget pages 20 through 24 of the budget
2 book, provided that \$29,000, or so much thereof as may
3 be necessary, is to be used to provide housing
4 allowances to consular staff in Honolulu and,
5 notwithstanding any other section of Public Law No. 13-
6 46, shall not be reprogrammed or used for any other
7 purpose. Of the amount appropriated, \$141,800 shall be
8 deemed to come from carryover funds available under
9 section 215(a)(2) of Compact I for communications.

10 (3) Department of Finance and Administration
11 \$2,439,532 for the activities set forth in the
12 performance budget pages 73 through 77 of the budget
13 book, provided that \$100,000 of this amount shall be
14 used to fund a portion of the deficit recorded by the
15 National Government at the close of fiscal year 2003
16 (which funds have been reprogrammed for disaster relief
17 under the President's emergency powers). Of the total
18 funds appropriated, \$46,914 shall be deemed to come from
19 carryover funds available under section 215(a)(2) of
20 Compact I for communications.

21 (4) Department of Economic Affairs
22 \$1,071,353, for the activities set forth in the
23 performance budget pages 126 through 132 of the budget
24 book. Of the total funds appropriated, \$29,381 shall be
25 deemed to come from carryover funds available under

1 section 215(a)(2) of Compact I for communications.

2 (5) Department of Transportation, Communication and
3 Infrastructure
4 \$1,314,922, for the activities set forth in the
5 performance budget pages 183 through 185 of the budget
6 book; provided that \$50,000 for fuel for the M/S Voyager
7 shall only be allotted upon the written acknowledgement
8 of the Speaker of Congress confirming his receipt of a
9 satisfactory accounting of the M/S Voyager Revolving
10 Fund, a report on the revenues generated by the M/S
11 Voyager in FY05 and a plan for earning revenues or
12 serving the people of the Federated States of Micronesia
13 during the remaining excursions of the M/S Voyager in
14 FY05. Of the total funds appropriated, \$20,000 shall be
15 deemed to come from carryover funds available under
16 section 215(b)(2) of Compact I for communications.

17 (6) Department of Health, Education and Social Affairs
18 \$1,526,808, for a portion of the activities set forth in
19 the performance budget pages 210 through 216 of the
20 budget book. Of the total funds appropriated, \$50,000
21 shall be deemed to come from carryover funds available
22 under section 216(a)(2) of Compact I for Health,
23 \$475,200 shall be deemed to come from funds available
24 under the education sector of the Amended Compact,
25 \$763,234 from the health sector, and \$111,421 from the

1 environment sector.

2 (7) Department of Justice
3 \$2,604,538, for the activities set forth in the
4 performance budget pages 339 through 342 of the budget
5 book provided that no more than \$31,000 of this amount
6 may be expended on fuel oil for National Police Patrol
7 boats until the Department has submitted to Congress an
8 accounting concerning the use of fuel oil for this
9 purpose in fiscal year 2004, including a description of
10 each trip taken and the amount and cost of fuel used for
11 each trip. Of the total funds appropriated, \$37,000
12 shall be deemed to come from carryover funds available
13 under section 215(b)(2) of Compact I for communications,
14 \$48,480 from carryover funds available under section
15 216(a)(1) of Compact I for Maritime Surveillance, and
16 \$47,486 from carryover funds available under 216(b) of
17 Compact I for Marine Surveillance.

18 (8) FSM Public Defender Office
19 \$677,513, for the activities set forth in the
20 performance budget pages 372 through 373 of the budget
21 book provided that \$16,000, or so much thereof as may be
22 necessary, is to be used for payment of the professional
23 premium to any eligible person or persons, and
24 notwithstanding any other section of Public Law No. 13-
25 46, shall not be reprogrammed or used for any other

1 purpose. Of the total funds appropriated, \$9,800 shall
2 be deemed to come from carryover funds available under
3 section 215(b)(2) of Compact I for communications.

4 (9) Office of Compact Management

5 \$100,000 to fund the establishment and operations of an
6 Office of Compact Management in accordance with Public
7 Law No. 13-75, provided that these funds shall not be
8 used to meet the cost of activities that are already
9 being undertaken within the National Government."

10 Section 2. Section 3 of Public Law No. 13-46, as amended by
11 Public Laws No. 13-62, 13-81 and 13-87, is hereby further amended
12 to read as follows:

13 "Section 3. Operating Expenses of the Legislative Branch. The
14 the fiscal year ending September 30, 2005, for the
15 operations of the Legislative Branch of the National
16 Government during the fiscal year 2005, in order to
17 achieve the activities set forth in the performance
18 budget pages 380 through 381 of the budget book. Of the
19 funds appropriated, \$40,000 shall be deemed to come from
20 the carryover funds available under section 215(b)(2) of
21 Compact I for communications."

22 Section 3. Section 9 of Public Law No. 13-46, as amended by
23 Public Law No. 13-81 and 13-87, is hereby further amended to read
24 as follows:

25 "Section 9. Capital and Human Resource Development.

1 The sum of \$8,185,287, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund
3 of the Federated States of Micronesia for the fiscal
4 year ending September 30, 2005, for the following
5 capital improvements, development programs and projects
6 and human resource development. The sum appropriated
7 under this section shall be apportioned as follows:

8 (1) College of Micronesia-FSM

9 (a) Operations of the College of Micronesia-FSM,
10 including planning, construction and maintenance of
11 college facilities. All funds appropriated
12 herein shall be deemed to come from funds
13 available under the education sector of
14 the Amended Compact\$ 3,856,067

15 (b) Student assistance for tuition
16 and housing, COM-FSM, provided that all
17 of the funds appropriated herein shall be
18 deemed to come from carryover funds
19 available under section 216(a)(3) of
20 Compact I for postsecondary scholarships ... 190,000

21 (c) COM-FSM Yap Campus Facility,
22 PROVIDED THAT funds appropriated herein
23 shall be deemed to come from funds available
24 under the infrastructure development
25 sector of the Amended Compact\$ 330,000

1	(2) FSM Fisheries and Maritime Institute,	
2	including operations, planning, training,	
3	and construction and maintenance of	
4	facilities and equipment. Of this amount	
5	\$180,050, shall be deemed to come from	
6	funds available under the education sector	
7	of the Amended Compact	738,360
8	(3) National Staff Upgrading, PROVIDED	
9	THAT funds appropriated herein shall be	
10	deemed to come from funds available under	
11	the capacity building sector of the	
12	Amended Compact	50,000
13	(4) FSM Visitors Bureau provided that,	
14	of this amount, \$40,000 shall be used to	
15	support FSM relations with JATA and	
16	participation in JATA programs and events ..	140,000
17	(5) Economic Statistics Unit Strengthening	75,000
18	(6) Crop Production Improvement	27,300
19	(7) Public Enterprise Privatization	66,560
20	(8) 2005 World Exposition (Japan)	82,000
21	(9) FSM Development Bank - Business	
22	Development Loan Program	500,000
23	(10) MS Caroline Voyager Dry-docking	630,000
24	(11) Patrol boats slipping	\$ 200,000
25	(12) Project Management Unit (PMU), PROVIDED	

1 THAT the sum appropriated in this line item
2 shall be deemed to come from funds available
3 under the infrastructure development
4 sector of the Amended Compact 1,000,000
5 (13) FSM trust fund 250,000

7 ~~Delekapw road paving supplement 50,000"~~

8 Section 4. This act shall become law upon approval by the
9 President of the Federated States of Micronesia or upon its
10 becoming law without such approval.
