



Dear Speaker Figir:



While I fully support the intent to salvage the vocational T-3 program and the need for social projects and programs, I am concerned about the appropriation for operational cost of Delegation Office and Election Districts, again whether or not funding for these entities should be strictly under the regular budget law for operation cost of all branches, departments, offices, agencies, authorities and entities of the national government. Severance is necessary to avoid double funding or any legal setbacks if any. With these concerns, I hereby transmit to you Congressional Act No. 15-90, which become Public Law No. 15-80 without my signature, entitled:

PUBLIC LAW No. 15-80

AN ACT

To appropriate \$540,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2009, for the purpose of funding the T-3 Program Operation, public projects and social programs in the States of Chuuk, Yap, Pohnpei and Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

17	(1) General Provisions.
18	(a) All funds appropriated by this act shall be
19	allotted, managed, administered and accounted for in accordance
20	with applicable law, including, but not limited to, the Financial
21	Management Act of 1979 and the amended Compact of Free Association
22	between the United States Government and the Government of the
23	Federated States of Micronesia and its related agreements.
24	(b) The allottees shall be responsible for
25	ensuring that these funds, or so much thereof as may be

1	necessary, are used solely for the purpose specified in this
2	act, and that no obligations are incurred in excess of the sum
3	appropriated.
4	(2) <u>Allottees</u> . The allottee of the funds appropriated
5	by this act are as follows:
6	(a) Subsection 1 of Section 1 - the allottee of
7	these funds shall be the President of the Federated States of
8	Micronesia or his designee;
9	(b) Subsection 2 of Section 1 - the allottee of
10	these funds shall be the Governor of Yap State or his designee;
11	(c) Subsection 3 of Section $1 - $ the allottee of
12	these funds shall be the President of the Federated States of
13	Micronesia or his designee;
14	(d) Subsection 4 of Section 1 — the allottee of
15	these funds shall be the Chuuk State Commission on Improvement
16	Projects;
17	(e) Subsection 5 of Section 1 — the allottee of
18	these funds shall be the President of the Federated States of
19	Micronesia or his designee.
20	(3) <u>Lapse Date</u> . The authority of the allottee to
21	obligate funds appropriated by this act shall not lapse until
22	fully expended.
