**PUBLIC LAW No. 15-13**

AN ACT

To further amend Public Law No. 14-84, as amended, by amending sections 1 and 9 thereof, to change the uses and allottee of certain funds previously appropriated therein for public projects and social programs in the State of Kosrae, and for other purposes.

1       Section 1. Section 1 of Public Law No. 14-84, as amended by  
2 Public Laws Nos. 14-96, 14-103 and 14-108, is hereby further  
3 amended to read as follows:

4               "Section 1. The sum of \$450,552 or so much thereof as  
5 may be necessary that lapsed as of June 30, 2006 as  
6 required by Public Law No. 14-35 from Public Laws Nos.  
7 7-107, 8-115, 8-19, 9-052, 9-095, 10-120, 10-143, 11-36  
8 and 11-59 for the State of Kosrae, is hereby  
9 reappropriated from the General Fund of the Federated  
10 States of Micronesia for the purpose of funding  
11 infrastructure projects, economic development projects  
12 and social programs in the State of Kosrae is  
13 apportioned as follows:

14 Section 2. Section 9 of Public Law No. 14-84, is hereby  
 15 amended to read as follows:


16 "Section 9. All funds appropriated by this act shall be  
 17 allotted, managed, administered, and accounted for in  
 18 accordance with applicable law, including, but not  
 19 limited to, the Financial Management Act of 1979. The  
 20 allottee of the funds appropriated in Section 1 of this  
 21 Act shall be the President of the Federated States of  
 22 Micronesia or the President's designee, PROVIDED THAT  
 23 the allottee of funds appropriated in subsection (1) (f)  
 24 of Section 1 of this Act shall be the Governor of the  
 25 State of Kosrae. The allottee of the funds appropriated



1 in Sections 2, 3 and 4 of this Act shall be the Chuuk  
2 State Commission on Improvement Project. The allottee  
3 shall be responsible for ensuring that these funds, or  
4 so much thereof as may be necessary, are used solely for  
5 the purpose specified in this act, and that no  
6 obligations are incurred in excess of the sum  
7 appropriated. The authority of the allottee to obligate  
8 funds appropriated by this act shall lapse as of  
9 September 30, 2008."

10 Section 3. This act shall become law upon approval by the  
11 President of the Federated States of Micronesia or upon its  
12 becoming law without such approval.
