A BILL FOR AN ACT

To further amend Section 3 of Public Law No. 15-55, as amended, to modify the use of funds previously appropriated therein for the operation of the Legislative Branch of the National Government of the Federated States of Micronesia for the fiscal year 2009, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
